Welcome to the Abuse in Later Life Education Series for Advocates. Domestic and sexual abuse victim advocates provide invaluable support and resources to victims in most communities throughout the United States. This education series is intended to expand on what advocates already know and help advocates recognize and respond to some of the unique issues experienced by older survivors. Programs may find the education series useful for new staff and volunteer training, as well as training seasoned advocates who want to learn more about abuse in later life. Our intention is to make training easily accessible, giving advocates an opportunity to learn at their desk.
