Please call the association office by May 15 to let us know you need a chaperone. These chaperones will NOT dispense medicine. All chaperones MUST have a current background check and we MUST have a copy. We STONGLY urge churches to send someone with children.

Camp Rules

Please give to your chaperones before camp. Remember you need a background check on workers! We will need a copy of the background check for anyone over 18.

* Let's have empathy and understanding for campers with allergies. - PLEASE DO NOT SEND SNACKS TO CAMP. This is a peanut free camp. Their fees cover their canteens.

We want campers to grow and join in the fun by participating in group activities.

For safety reasons, campers should not roam alone, we like the "three buddy system!" Never are campers to be alone in the cabins, nor near the lakes, or pool.

Personal vehicles are not allowed beyond dining halls during the week.

Remember this is a Christian camp, please dress accordingly, which means modestly, and careful of the tee shirt ads.

Campers cannot leave the camp and return for any purpose except doctors' (or dentists') appointments or other emergencies. Parents must notify camp director if child will be leaving during the week. If a camper is sick and needs to leave camp, they may return if they are feeling better and are not contagious.

There is no smoking on camp grounds.

Please do not allow campers to write or deface any camp property this includes bunks!

The buildings and grounds should be picked- up daily. Campers are responsible for own litter.

Chaperones should encourage campers to abstain from caffeine sodas at the last canteen. Chaperones are to encourage campers to keep order in cabins.

DO NOT ALLOW campers out of cabins after curfew! Breaking this rule could mean expulsion from camp.

Chaperones/camp workers should be familiar with campers and any health concerns or behavior issues which campers may have.

Chaperones who have campers on meds, are responsible for meds and keeping meds in a safe place. If church does not send chaperone, our staff will need to be made aware of all meds.

Chaperones will help lead groups in daily prayer and Bible Study.

Chaperones should be positive and encouraging with campers and camp staff at all times.

Before the afternoon swim time everyone should use the sunscreen at the top of the hill. If a camper has skin sensitivity, then their chaperone may oversee the application of the child's personal sun screen. But they should walk the child through the sun screen booth. Our goal is to stop sunburns during children's camp!
