Retrieval of Property (Unmarried)* "How do I get my stuff back?"

Immediate Retrieval

As long as you have signed the lease, you have the right to enter and retrieve your property. Your landlord should let you in to retrieve your things.

It is recommended that you request a sheriff or police officer escort during this process.

If ownership of an item is disputed, the officer probably will not allow you to take it. Take photos of all items left behind to prove their condition and location.

Sheriff or Police Escort

If you have been granted a temporary restraining order, injunction, or other no-contact order, you may request a sheriff or police officer accompany you when you retrieve your property, even if you are not on the lease.

You will be limited to taking only personal property over a short period of time.

Replevin

You can file in small claims court to reclaim property valued less than \$10,000 up to six years after you leave it behind. 1

You must show the court:²

- (a) That you are entitled to possession of the objects (e.g., receipts, notes from a giftgiver, etc)
- (b) That the property is wrongfully detained (kept without permission)
- (c) The value and location of the property

Disposal of Property (Unmarried)*

"How do I get rid of this stuff?"

Immediate Disposal of Property

Dispose of the property left behind as you choose. The owner may take legal action for the value of the property if s/he has retained proof of ownership, such as receipts.

Certified Mail Notice

Send a letter via certified mail notifying the abuser of your intent to dispose of the property within a certain number of days unless it is retrieved. It is recommended to allow a minimum of thirty days before disposal.⁴

Sending this letter does not prevent further legal action by the abuser.

Avoiding Replevin

Hold the property for 6 years, until the statute of limitations for Replevin actions passes. (See other side for Replevin details)

Sheriff or Police Escort

If your abuser is subject to a restraining order that would otherwise prohibit contact and is coming to get property, contact law enforcement to supervise the exchange.

You may request law enforcement supervision without a restraining order. However, whether law enforcement responds to these requests is discretionary.
