STATEWIDE & NATIONAL TRAININGS

Responding to Stalking & Strangulation Cases

January 30
Richland Center, WI

During this training, hosted by **Wisconsin Department of Justice** staff member, Keeley Crowley, participants will delve into the investigation of stalking cases. We will explore how to conduct thorough investigations, including evidence preservation and collection as well as investigative strategies for interviewing victims and suspects. It is imperative that each person working in the criminal justice field work together to hold offenders accountable and keep victims safe. As a result of this training law enforcement will have a better understanding of the unique challenges for handling a stalking case or a case that involves stalking behavior, whether or not stalking is charged.

The second part of this training is intended to aid law enforcement in understanding the complexities of strangulation to enhance overall investigation efforts. Specifically, participants will understand the mechanisms used during strangulation and how those

operate on the victim to either stop blood flow or cut off the airway or both. The symptoms experienced by the victim of each kind of strangulation will be discussed, and connections made between those symptoms and the law enforcement interview.

Officers who participate in this training will gain a deeper understanding for the serious impact of strangulation and its connection to lethality, and will develop tools for successfully investigating and presenting strangulation cases.

Building and Sustaining an Effective Response to Domestic Violence Crimes: The Blueprint for Safety St. Paul Success 8 Years Later

January 10
2:00pm - 3:15pm CST

In 2010 the City of Saint Paul, Minnesota, launched an ambitious approach to its response to domestic violence-related crimes. This project, known as the Blueprint for Safety, has transformed the City's ability to effectively intervene in these cases. Working closely with the local advocacy program, city and county officials have developed new ways of engaging with one another and, more importantly, with victims of violence. The Blueprint has been adapted and implemented in a number of other jurisdictions across the country, but Saint Paul, as the originator and the longest practicing Blueprint community, stands out

as a site where the new practices in the Blueprint have become almost second nature and are now part of the landscape of the community response to domestic violence. Learn from local criminal justice practitioners and advocates about how they were able to institutionalize this ground-breaking work and the difference it's made in their community. Trauma Informed Victim Interview (TIVI) for the Justice System - Part 2

By acknowledging that these interviews are structured for the justice system and to effectively build a case, we will start by showing what information and evidence may be uncovered using this interview method, how to facilitate the interview, and how to recognize when and how follow-up questions should be asked. We will listen to interviews and point out the difference between inadequate questions and strong questions. We will discuss the new evidence that has been uncovered by this interview method and how to use it to build a strong case.

Navigating Bankruptcy & Student Loan Solutions with Survivors (Webinar Series)

Part 1 (Bankruptcy): January 16 | 1:00pm - 2:30pm CST
Part 2 (Student Loans): January 30 | 1:00pm - 2:30pm CST

Part 1: Bankruptcy

Given what we know about the economic hardship survivors face as a result of abuse – debt in particular – filing bankruptcy can be a powerful tool for survivors to obtain relief. However, there are important safety and privacy factors to consider, alternatives to weigh, and handling and enforcing debt relief in family or domestic violence courts is often limited, while bankruptcy law can feel unfamiliar or inaccessible to many attorneys and advocates working with survivors.

In this webinar, hosted by the **Center for Survivor Agency & Justice**, Karen Tjapkes will unpack the bankruptcy process, share legal remedies and strategies, and walk through case scenarios in order to enhance individual survivor centered economic advocacy. Attendees will walk away from Part 1:

1. More familiar with concepts in bankruptcy.
2. Able to identify when bankruptcy might be an option to address debt facing survivors.
3. Having explored the connection between bankruptcy and family law, identifying and discussing key strategies in case scenarios.
4. Equipped with unique or innovative practices from group discussion.

Part 2: Student Loans

Student loan debt is one of the largest sources of debt in the U.S., generally. And survivors face unique risks of not being able to pay (default), as well as challenges in resolving, paying off, and/or accessing new student loans. This can result in restricting a range of options for economic security, including access to housing, employment, and future education. Thus, helping a survivor avoid or get out of default may be important to their long-term financial security. This webinar will help attendees better understand the student loan system, options, and integrate student loan strategies into a holistic, survivor centered economic advocacy approach.

In this webinar, Persis Yu, from the National Consumer Law Center, will provide an overview of the student loan system, options and common issues for survivors, and provide in-depth strategies to get survivors out of default and into income driven repayment plans.

Attendees will walk away from Part 2:

1. Familiar with how student loans impact survivors and their families.
2. Able to issue-spot the kinds of loans survivors have, and potential problems.
3. Able to discuss the unique pitfalls or challenges survivors face when getting into income driven repayment plans.
4. Equipped with strategies to address challenges, from discussion and case scenarios.

Signs of Elder Abuse, Neglect, and Exploitation

Lawyers and others who work with older adults should be aware of potential signs of abuse, neglect, and exploitation. This awareness requires an understanding of abuse signs, as well as the questions to ask when abuse is suspected. As the first part in the forthcoming National Center on Law and Elder Rights (NCLER) Elder Justice Toolkit, [this webcast](#) will help lawyers tune in to potential warning signals and learn key questions to ask when elder abuse is suspected.

The fast paced, one-hour program, hosted by the **National Center on Law & Elder Rights**, will include checklists of signs of physical, behavioral, emotional, and sexual abuse, self-neglect, caregiver neglect, and exploitation.

Predicting Intimate Partner Violence Injuries Based on Police Reports

January 16
2:00pm - 3:00pm CST

Approximately half of all victims of intimate partner violence are injured (Truman & Morgan, 2014). There are several different sociodemographic and incident related factors that increase the likelihood of victims being injured such as being a woman, having children present, and the perpetrator being under the influence of alcohol. In this webinar, hosted by the **Battered Women's Justice Project**, we will look at results from a study of police reports of intimate partner violence incidents in South Carolina during a one-year period. In this project, the aim was to use information from police reports to predict visible injuries in victims of intimate partner violence. A range of sociodemographic as well as situation-specific factors was explored as possibly affecting the likelihood of a victim being injured. Specific recommendations will be discussed in regards to documentation of intimate partner violence in police reports.

Multiple Victim Homicides, Mass Murders, and Homicide-Suicide as Domestic Violence Events

January 24
1:00pm - 2:30pm CST

While intimate partner homicides are generally discussed as events in which there is a single homicide victim, they often involve multiple homicide victims and even the homicide offender's suicide. These additional homicide victims are often the children of the targeted intimate partner, though they are also other family members, friends, acquaintances, or others. Sometimes the number of people killed in an intimate partner homicide event reaches four or more, making it a mass murder. This webinar, hosted by the **Battered Women's Justice Project**, will cover how often multiple victim intimate partner homicides and homicide-suicides occur, the frequency of firearm use in these homicides, and opportunities for intervention.
