### National Institute on the Prosecution of Domestic Violence

July 9 - 12  
Washington, D.C.

The National Institute on the Prosecution of Domestic Violence (NIPDV) is a three-and-a-half-day interactive training that explores the complex issues that arise in intimate partner violence cases. The Institute challenges prosecutors to exercise sound judgment and creativity in their efforts to hold offenders accountable while minimizing the burdens that

the criminal justice process places on victims. The curriculum focuses on the importance of evidence-based prosecution and includes the following topics

- Practical case evaluation
- Risk assessment
- Coordinated community response
- Trauma-informed interviewing
- Strangulation
- Witness intimidation and forfeiture by wrongdoing
- Trial strategies
- Expert testimony
- Cultural humility
- Ethical considerations

This training is **open to prosecutors only, and attendance is free of charge**; however, priority will be given to OVW grantees.

- How can we ensure that our programs provide equal access to all survivors in shelter, regardless of gender identity or sexual orientation?
- What are some concerns for agencies in providing shelter to LGBTQ survivors experiencing intimate partner violence?
- How can we use our wisdom as advocates to identify what the pattern of abusive power and control looks like in LGBTQ relationships?

In order to effectively work with LGBTQ survivors, we must go deeper than just a checklist of abusive behaviors. It is key that we study context, intent, and impact of those behaviors. Together, let's explore the barriers and solutions to ensuring equal access to all survivors. ## Providing Accessible Services for Survivors of Domestic Violence and Sexual Assault Who are Blind or Have Low Vision
