# **Organizational Agility Is Born Out of Good Governance**

Organizational agility. Your capability to change and adapt; to keep up with technology, cultural shifts and overall market conditions. So how can you achieve new heights and remain agile as an organization? Think of governance as your springboard.

We're all striving for governance that works, but truly good governance can help you stay flexible in a changing market and meet new challenges head on. The key is to have your processes and procedures in place now—don't wait until there's a specific need. It's our job as association staff to help our boards anticipate change and adjust our governance accordingly. But how?

One way Association Forum adjusts is by implementing a cycle of improvement. It's a process that allows for planning, execution, measurement of progress and careful assessment. All of this is focused around our mission, vision and core values. It is important to continually adapt and strive for better processes, but also to stay focused on the foundational aspects of your association.

When Association Forum crafted our strategic plan in April of last year, we focused on where we wanted to be in the year 2025. We captured objectives, tied them to initiatives and applied measurements for success. But we also put our mission, vision and core values at the center of every decision. - **3.** Consider moving governance documents to Google Drive or your organization's website to make them searchable for staff and board members. Organizations tend to have one staff person who is the "governance guru." While this person is extremely valuable, all staff and board members should be held accountable for reading and understanding basic procedures and policies.

Finally, the best way to stay agile in this new decade is to adopt a growth mindset. Make sure your staff and board members are always on the lookout for opportunity within and outside of the organization. Be diligent in your maintenance of governance documents, but also be willing to make changes when needed. We can't know what the next 10, 15 or 50 years have in store, but we can prepare our organizations to take change in stride and flourish for decades to come.

# Q: I UNDERSTAND THAT THERE HAS BEEN RENEWED SCRUTINY OF THE QUALIFICATIONS FOR INDEPENDENT CONTRACTOR STATUS. WHAT NEEDS TO BE INCLUDED IN MY INDEPENDENT CONTRACTOR AGREEMENTS TO AVOID ANY PROBLEMS?

A: To distinguish independent contractor from employer-employee relationships, the most important provisions to be included in an independent contractor agreement are those documenting the individual's independence and control over his or her work. Proper classification of workers as employees or independent contractors is essential, especially in the eyes of the IRS, the Department of Labor and state employment agencies. If a worker is misclassified, the organization may be responsible for substantial federal and state tax, benefits and overtime liabilities. When evaluating whether a person providing services to the association is an employee or independent contractor, an association must consider all information that provides evidence of the degree of control and independence the person will have in performing his or her work.

The facts that provide evidence of the degree of control and independence fall into three established categories—behavioral, financial and type of relationship. Accordingly, independent contractor agreements should provide that, although the individual must report to the organization and follow its policies, the

contractor is responsible for the means, time and manner in which he or she provides services. The organization should not control or have the right to control what the contractor does or how he or she does the work. The agreement also should acknowledge that the contractor may work for others. And, it is prudent to have the agreement explicitly state that the contractor may not speak or act for the organization unless specifically authorized in writing.

Generally speaking, compensation to independent contractors should not resemble payments made to employees. In fact, opportunities for contractors to share profit or loss show greater independence. The agreement also must state the contractor is solely responsible for paying taxes and withholding, for providing benefits for the contractor and his or her employees and subcontractors, and for all expenses incurred in operating his or her business. Ideally, all the foregoing factors, taken together, will help demonstrate that the contractor is in business for him or herself, and not economically dependent on the organization for his or her livelihood.

Organizations must carefully consider and document each of the above factors in the independent contractor's agreement. While there is no established number of factors or criteria that definitively determine that a person qualifies as an independent contractor, the key is to evaluate the entire relationship, consider the degree or extent of the right to direct and control, and to document each of the factors used in making the association's determination. The following are other key provisions to include in independent contractor agreements:

# Clarify services, deliverables and timing up front.

Even when a project seems clearly defined at the outset, the independent contractor's view and the organization's view of the "scope of work" may differ. Make sure the agreement specifies the final product and all the elements important along the way: interim reports, phone calls, meetings, access to key contact people and deadlines. Because the scope of the project may change as the project progresses, make sure the agreement requires any changes in scope and cost to be agreed to in writing.

# Beware hidden costs or fees.

Fees for the project are inextricably intertwined with the project's scope. The organization must know what costs and expenses are included and what will be extra. The agreement should clearly state whether the fees are estimated or fixed or vary with time spent. The contract should delineate what expenses, if any, the organization will pay or reimburse. If compensation is based on "net revenue," net revenue must be defined.

# Own the work product.

A big frustration for organizations is finding out they don't own what they thought they bought. Unless the organization's ownership of the independent contractor's work product is clearly established in writing in the agreement, the creator (the contractor) owns the work, not the person who paid for it. The organization at best only has an implied license to use the independent contractor's work product. And, if third party intellectual property (e.g., software) is necessary to be able to use the work product, the agreement should ensure (1) the contractor has the unencumbered right to use the third party's intellectual property for the organization's purposes and (2) the organization has the right to continue to use the third party's intellectual property—through a

broad license—even after the work is complete or the agreement has been terminated.

# **Ensure confidential information** is protected.

The agreement should provide that the independent contractor will use the organization's confidential information—for example, membership lists, financial data, business plans and the work product itselfonly for the benefit of the organization. In other words, the independent contractor may not disclose information to anyone other than the organization or its representatives, such as the contractor's other clients, or use the organization's information in any way that would harm the organization. Provisions prohibiting solicitation of the organization's members or clients may also be important.

# Obtain performance assurances.

The independent contractor should be willing to stand behind his or her product or service and warrant that the work will be done professionally and meet other applicable standards in the field (e.g., as a software provider). In addition, he or she also should warrant that the product will not infringe others' copyright or trademark rights.

# Include indemnification.

The independent contractor should indemnify the organization for its work and against any representations or warranties made in the agreement. The organization should also consider provisions explicitly limiting its liability to the independent contractor.

# Clarify when and how the agreement terminates.

An agreement with an independent contractor should have a specific term, and it should be clear who has the right to terminate the agreement, and under what conditions, before the term expires.

The above list highlights the most important terms for agreements with independent contractors. Other typical contract provisions—notice, choice of law, assignment—also should be included to ensure the organization is well-protected.

# STAY UP TO DATE

Find the latest news on Chicago lobbying ethics at chicago.gov/ city/en/depts/ethics/ provdrs/lobby.html. As you may be aware, the City of Chicago's City Council adopted a new lobbyist registration ordinance (SO2019-5305) in July focused on ethics reform. Among other things, the new ordinance requires a nonprofit organization's paid staff, contractors and pro bono representatives, as well as volunteer leaders and organizers (in some circumstances), to register as lobbyists with the City if they represent or support a City law or ordinance that would further the interests of the organization or its membership. While generally supportive of the Mayor's efforts to implement ethics reform, the Forum had significant concerns with the new ordinance and was able to share those directly with the Mayor's office and the Board of Ethics.

Specifically, the Forum's efforts focused on improving the new ordinance's overly broad and vague definition of "lobbying" and overbroad and burdensome registration and reporting requirements for nonprofits.

The new ordinance was set to go into effect on January 20, 2020. Given the new requirements and the desire of all stakeholders that the ordinance be rolled out without undue hardship, we are happy to report that the Mayor has delayed the enforcement and effective date of the nonprofit lobbyist registration requirements by three (3) months to April 20, 2020. In the meantime, the City Board of Ethics has been directed to develop rules and advisory opinions to provide further

clarity and direction to nonprofits and their leaders regarding their registration obligations under the new ordinance.

We will continue to advocate on behalf of the Forum and its members with respect to the ordinance and keep you informed of developments.

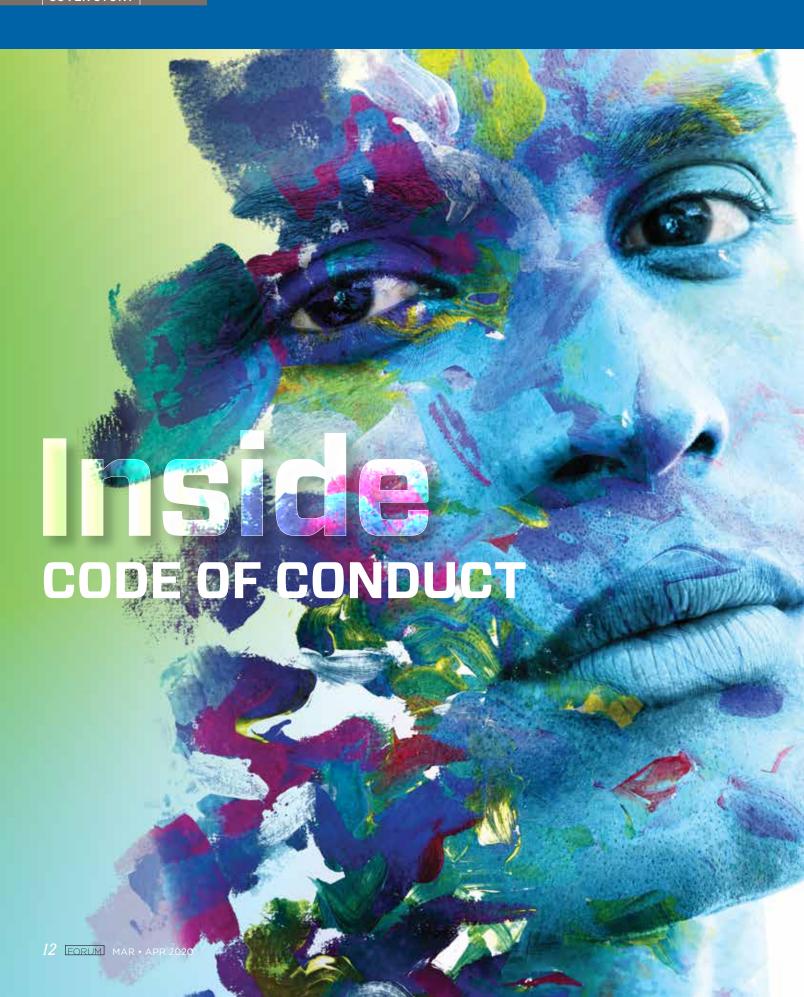

ddressing bad behavior by fans

is a top priority for the National Basketball Association (NBA). In a 2019 player poll conducted by "The Athletic," 13.7% cited fan behavior as the NBA's most pressing issue. Last season alone there were several incidents—including racist taunts—directed at players, including superstars Russell Westbrook, DeMarcus Cousins and Kyle Lowry. The fan code of conduct has been a standard announcement in every NBA arena for years. It's now being shown on gigantic video screens and promoted throughout each game. And the league is continuing to strengthen the code—zero tolerance for abusive or hateful behavior will be the policy moving forward, according to NBA.com.

Professional and trade associations are similarly playing both offense and defense with their codes of conduct to address issues on their own courts particularly at conferences and on social media where member interactions are heightened. No matter the venue, there's no room for hateful behavior or bullying, and addressing such violations is crucial. Associations are also finding creative ways to remind members about their codes of conduct, tuning up their codes to apply to virtual environments, and incorporating inclusivity language to fortify policies and procedures. There are both bold and small actions that you can take to help shape members' positive interactions within your association.

# Be Intentional and **Aspirational**

According to the Ethics and Compliance Institute, a well-written code of conduct clarifies an organization's mission, values and principles, linking them with standards of professional conduct. A code spells out values the organization wishes to foster and, in doing so, defines desired behavior.

"We use the code in a proactive way—we intend for it to be aspirational," says Marty Wolf, co-chair of the leadership team for the Committee on Professional Ethics of the Association of Computing Machinery (ACM). Wolf was part of a volunteer-led initiative that improved the code for ACM's 100.000 members.

"We envision helping people to have conversations about ethics and social responsibility first as students and then in the workplace," adds Wolf, who is also a professor of math and computer science at Bemidji State University.

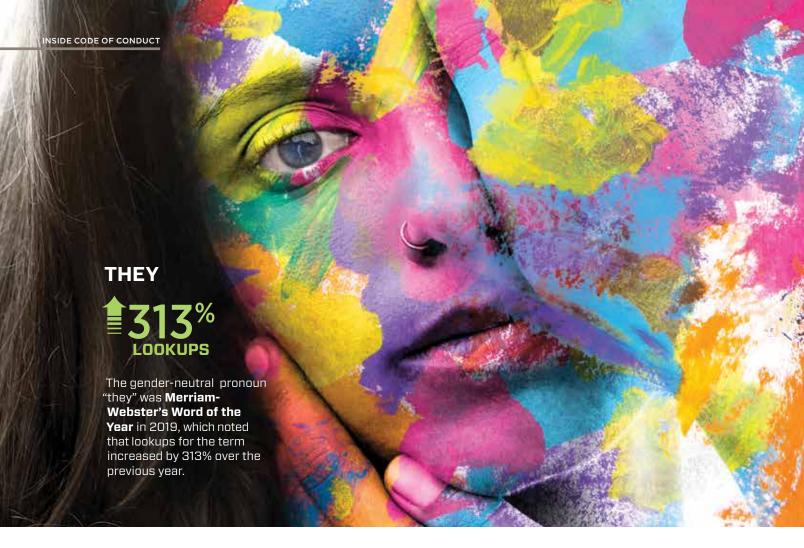

We use the code in a proactive way we intend for it to be aspirational. We envision helping people to have conversations about ethics and social responsibility first as students and then in the workplace."

and ACM goes to great lengths to promote it. Every ACM member agrees to support the Code when they renew their membership. ACM produced a "Code Booklet" that is distributed to all members and at conferences and workshops.

"We have representatives speak about the Code and computing ethics in general—at workshops, conferences and workplaces around the world," Wolf says. "Most textbooks that are geared toward computing ethics include the Code and often contain a chapter that introduces it."



In addition to the Code, the ACM has a policy against harassment. Every conference supported by ACM must implement this policy. Participants are advised of the policy at the time of registration. Attendees are reminded of this policy and its highlights during the opening plenary session.

The American Dental Association's (ADA) codes of conduct apply to its various stakeholders. Its Member Conduct Policy was adopted in 2011 and is part of ADA's policy manual. Its Professional Conduct Policy and Prohibition Against Harassment is addressed during the onboarding of employees and is included in the ADA employee handbook.

Although the ADA's core values and precepts including its codes of conduct and policies of diversity and inclusion—permeate its annual meeting, there is no specific reference to the codes of conduct at the actual conference. ADA's Professional Conduct Policy does, however, explicitly state that it is applicable at all association functions and events.

In addition, all volunteers participate in an orientation when taking a leadership position at the ADA. The orientation includes a detailed discussion of all aspects of the Member Conduct Policy and Professional Conduct Policy, as well as principles of corporate governance, conflict of interest and

the importance of diversity and inclusion to the sustainability of the association.

# **Cultivate Online Civility**

One of the biggest challenges that associations face is civility on virtual channels. From blogs to websites to social media, there are continuous opportunities for posting and virtual interaction. To elevate discourse and foster meaningful social engagement, the American Medical Association (AMA) has a digital code of conduct that outlines its community guidelines and expectations for those engaging with its posts, as well as for employees who are active on social media and AMA members who amplify AMA messages.

"Our code of conduct is our North Star," says Caitlin Ganet, AMA's senior manager for Social Media and Community Engagement. "We strictly enforce our code of conduct when it comes to hate speech, discriminatory language and the spreading of blatant misinformation—all of which are prohibited."

Violations of the code are dealt with on a caseby-case basis, as each is unique. "With our grounding in science and medicine, we encourage discussion and the exchange of ideas," Ganet adds. "But when someone is in plain violation of our code of conduct,

In 2019, AMA shared an image and story of a female physician who wears a hijab. The innocuous post unleashed a number of racist comments, all of which were irrelevant and brazenly discriminatory. The comments upset not only the individual being profiled but also a number of AMA members and board members who saw the post.

"Our team rushed into action, hiding comments and banning users who clearly violated our code of conduct," Ganet states.

"In those instances, we view banning as a warranted response, because there is no place for hate speech in the space we've created to celebrate physicians."

ADA reported that it also maintains a separate policy covering proper use of social media. That policy is applicable to both employees and volunteers. The policy is addressed during onboarding and a copy of the policy is accessible to all employees and volunteers. Infractions by staff would be addressed by the Human Resources Division, while issues with volunteers would be addressed within ADA's leadership structure, including, if warranted, the Board of Trustees.

# Take Small Actions

The Digital Library Federation (DLF), which has nearly 200 member institutions, provides specific examples in its Code of Conduct of how to provide a conference experience that is inclusive of all people. DLF refers to them as "small actions" that attendees and presenters can take to meet this goal: "We suggest: listening as much as you speak; encouraging and yielding the floor to those whose viewpoints may be underrepresented in a group; using welcoming language, for instance by honoring pronoun preferences and favoring gender-neutral collective nouns ('people,' not 'guys'); accepting critique graciously and offering it constructively; giving credit where it is due ..."

Many of these small actions can easily be incorporated by associations. The one gaining traction in

many organizations has to do with language. While using respectful language in general is implicit in daily conduct, there's a growing sensitivity to pronoun usage, as the DLF code illustrates. In fact, the gender-neutral pronoun "they" was Merriam-Webster's Word of the Year in 2019, which noted that lookups for the term increased by 313% over the previous year. As Merriam-Webster. com further explains, "More recently, though, 'they' has also been used to refer to one person whose gender identity is nonbinary, a sense that is increasingly common in published, edited text, as well as social media and in daily personal interactions between English speakers."

DLF's code of conduct helps to foster an inclusive and welcoming environment. DLF requests attendees' pronoun preferences on conference registration forms and instructs panel moderators to ask every panelist their pronoun preference.

Members have embraced this code improvement. "I have made it a practice to wear an enamel pin to every conference with my pronouns," says Rebecca Pattillo (she/her), metadata librarian in Archives and Special Collections at the University of Louisville.

# **Revisit and Reinforce**

Codes of conduct allow us to engage positively and productively within our communities by spelling out the values our organizations wish to foster and, in the process, defining desired behavior. Consider what steps your association might take to improve interactions among your members. Whether revisiting your code, developing one specifically for social media, or encouraging the use of inclusive language, it's an opportunity to reinforce a shared mission. While having a code of conduct may not always be a slam dunk for best behavior, it's still one of the most important policies your organization can put into action.

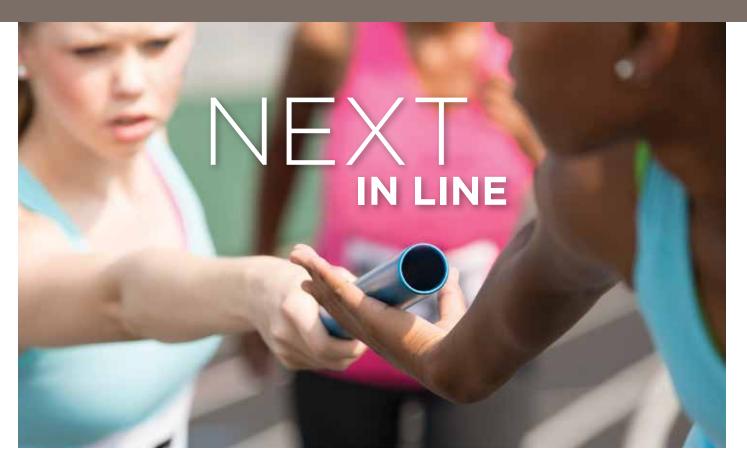

Your association's success relies on volunteer succession.

stablishing and executing a volunteer succession strategy is a daunting, yet necessary responsibility faced by leaders of nonprofit organizations. Poor transition planning for the board and key committees can result

in stagnation, disruption and failure for the association. Therefore, it is essential that an organization's volunteer succession plan factors in multiple contingencies to ensure that the organization has the volunteers needed to move and achieve its long-term goals and mission. A thoughtful approach to succession planning allows future administrations to further the work of its predecessors.

A strategic succession plan involves creating a framework that accounts for the what-ifs and life-changing events that affect volunteers. It also entails creating a pipeline of volunteers, and ensuring those volunteers are the right fit and prepared for their future duties. Once established,

the succession plan should grow and evolve with the organization. Following are some tips from organizations that have achieved volunteer succession success.

# The Framework for **Volunteer Succession**

An effective volunteer succession plan starts with goals and a clear vision. What do you want the plan to achieve? What processes are required? What roles does the plan encompass and who are the decision makers?

For Community of Experts of Dassault Systèmes Solutions (COE), the board is proactive in its approach to volunteer succession, says Executive Director Bret Kelsey.

"The best time to create a succession plan is when things are going well and you have good people in place," says Kelsey, a 27-year veteran of association management.

For COE, the focus is on finding the right volunteers to serve on the board.

Committee chairs or task force heads are often tapped, but Kelsey cautions

the decision-making should be thoughtful. Not all committee chairs are in strategic roles, because some committees require more hands-on. tactical work. In general, though, committee leaders are a great source of potential board talent. And the pipeline for

committee leadership should be a focus of the organization's overall succession plan.

Another important part of the process is clearly identifying—and communicating—the roles, responsibilities and expectations for each of the leadership positions. COE reports annually to its membership regarding the board succession plans as well as what the board roles entail. The report achieves two goals: transparency about board activities and recruitment for future leadership service.

Other criteria detailed in the plan should include length of service for both board members and officers. Kelsey suggests that boards turn over every four to six years, which would mean two- or three-year terms for individual board members. The board member would then either get in the leadership queue to become an officer or move off the board. Again, there may be individuals who move up more guickly based on need or other circumstances, but this is a basic structure for successful organizations.

Kelsey also recommends having one-year terms for officer positions, but no more than two-year terms. So, if there are three officer positions, and a volunteer eventually serves in each role, this would require another three or four years on the board. In all, you would be asking for a seven- to 10-year commitment from volunteers who serve on the board and move into leadership roles. That's not

including any time spent on committees or task forces. For many associations, this

> structure effectively identifies and grooms new volunteer leaders while maintaining continuity from one board to the next.

The board should also set aside time for self-assessment to think about board composition in light of the association's overall strategic plan. Which

skills, competencies or representation might the board need going forward to advance the mission and meet strategic goals? More importantly, what is currently missing on the board—such as representation, skills or thought leadership? "You want critical thinkers, but you also want a diversity of opinion. Not people that just 'think like us.' You don't want to slow the organization from growing and innovating," Kelsey says.

Finally, Kelsey notes that the association should have a rigorous process for identifying and recruiting the right volunteer leaders. This process should run through a Nominating Committee or Leadership Management Committee tasked with finding, recruiting, vetting and assigning volunteers to positions that put them on the right track to become leaders.

# **Creating a Pipeline**

Once a succession plan is in place, long-term success is dependent on developing a pipeline of volunteers. More than a decade ago, the Society of Gastroenterology Nurses and Associates, Inc. (SGNA)—an 8,000-member professional association of nurses and associates dedicated to the safe and effective practice of gastroenterology and endoscopy nursing—faced a volunteer drought. In response, its board launched a robust volunteer engagement effort designed to increase loyalty among its

members, improve retention and produce an always-ready pipeline of nextgeneration volunteers. Today, after years of refinement, SGNA has found itself in the enviable position of having a healthy reserve of ready-to-serve volunteers for its leadership positions within its board, committees and various task forces.

SGNA's systematic, annual process accomplishes the following:

- Identifies volunteer needs
- Clearly communicates expectations
- Provides mentorship and development opportunities
- Evaluates performance
- Elevates promising volunteers into positions of increased responsibility, from volunteer to association president

For the call-to-action, a multipronged approach is a best practice. Putting out a call through association meetings and events, in-house—or industry—publications, the website and social media sites is an effective way to reach great candidates. But active recruiting must also be a part of the strategy. Some associations even appoint talent councils, whose sole charge it is to find the right people to serve on boards, committees or advisory councils. These talent councils can also be used to mentor future board members. And no matter what tactics are employed, it's not enough to have one conference call a year to brainstorm potential candidates. It needs to be a year-round process.

"Remember to thank your committed volunteers—often," says SGNA Executive Director Kim Eskew. "Our volunteers deserve to feel appreciated and valued."

As you create a pipeline of volunteer candidates, Eskew recommends considering a variety of sources. Volunteers can step forward themselves, be nominated by someone else, be recommended by a board member, suggested by staff or be sought out by a nominating committee. Regardless, a vetting process should be conducted to discover which candidates have leadership potential.



Set the bar high in your search for future volunteer leaders. The best leadership candidates should exhibit not only the requisite experience and knowledge, but also the skills to enhance your organization. If you see members exhibiting these skills, iump in and ask them to volunteer!

- > Are they strategic thinkers?
- > Do they possess good judgment?
- > Are they consensus builders?
- > Do they value learning?
- > Do they have the time to commit?
- > Are they politically savvy?
- > Have they served in past volunteer leadership roles?
- > Do they have high ethical standards?
- > Do they inspire others?
- > Are they prepared to serve as stewards and ambassadors for the organization?
- > Do they bring diversity to the board in representation, skills or thinking?

The people who embody these qualities should be assigned to positions where they can gain leadership experience and visibility within the association. That might mean assigning them to lead a task force or work group, or appointing them to chair a committee. In these roles, they can hone and demonstrate their leadership skills, while also giving the organization a chance to see how they perform.

"Rather than recruiting each year on a one-off basis, we create a talent lineup that we can tap at any time," Eskew says. "You want to have a pipeline of people in your industry or profession who are interested, eligible and capable of serving."

# **Ensuring the Right Fit**

The process to build that pipeline needs to be year-round, which is the case for the Financial & Insurance Conference Professionals (FICP), an organization that provides access to education, experience and resources targeting the needs of financial services and insurance meeting professionals. "Research proves that most people don't volunteer unless they're asked—so it behooves the board or the committee members to have conversations throughout the year to identify potential new board members and educate them about the process," says FICP Executive Director Steve Bova. "Identifying and recruiting people to serve is a year-long sport."

Keep in mind that the complexity and speed of life today makes it more difficult for people to give the time—or make it a priority—to serve on a board. "It's a pretty big commitment that requires a lot of responsibility," says Bova. "It's not just showing up at a few meetings. It's about being engaged, serving and doing what is right for the organization."

Considering that fact, Bova recommends a proactive approach. The most successful organizations seek out the most talented board members, rather than just letting candidates come to

them. It's important to keep in mind great candidates are usually more than willing to serve if approached. "In many cases, people who seem reluctant to volunteer eagerly do so if asked," says Bova.

In addition, it's vital for people to understand the roles they are being offered and the expectations that come with it before making the commitment to serve. FICP uses a simple handout called "Before You Say Yes," which is a checklist to determine if the candidate understands what's required. For example, it asks if they fully appreciate the time commitment needed and understand the fiduciary obligations of serving. Also, it asks if they have the support of their employer, and if there are any conflicts of interest.

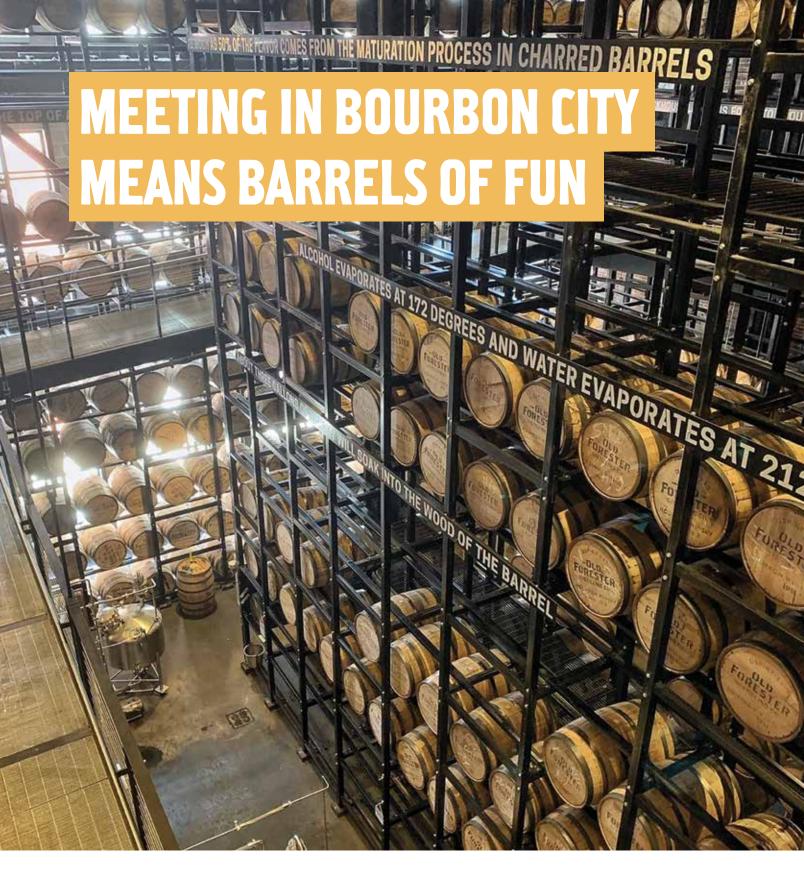
Further, FICP has a resource it gives to potential board members that outlines the benefits of serving. For the individual, it's an opportunity to grow personally and professionally, as well as affect change, give back, and be more involved as an industry leader. It also notes that serving will provide good visibility for the board member's company.

Finally, Bova notes that creating a valuable and beneficial volunteer experience might make volunteer leaders want to stick around indefinitely. However, if the same volunteers keep cycling through, it creates a perception that the organization group is a clique, which can be an unintentional threat to any succession process. A vital step in a good succession plan is ensuring volunteers understand when it is time to step down gracefully and let others step in.

Even with all these best practices in place, an association's volunteer recruitment efforts must be flexible so they can evolve as the organization and its industry or profession. Ultimately, these efforts are the key to ensuring the organization has a lasting and valuable impact.

Research-based strategies for good governance.

ill Brown, PhD, and Mark Engle, DM, FASAE CAE, both work closely with nonprofit associations; the former as director of the Center for Nonprofits and Philanthropy at Texas A&M's Bush School of

Government and Public Service, and the latter as a principal and board governance consultant at Association Management Center. Noticing that there were very few relevant and up-todate resources for boards to use, Brown and Engle conducted research for the ASAE Foundation on boards with a full spectrum of competencies. Their research and observations from working with boards pointed to the same conclusion: While high-performing boards shared certain common characteristics, struggling organizations usually did not have optimized boards or a clear sense of strategic direction. As a result, Brown and Engle created "Recruit the Right Board: Proven Processes for

Selecting Critical Competencies" as a resource for current and aspiring association board members. In turn, they are shaping the landscape of board orientation and capability.

In this interview, Brown and Engle provide insights into their research, processes and the essentiality of "Recruit the Right Board." As many decisions are made in the board room, processes are often stunted or bad decisions are made due to poor practices such as a lack of trust, dominating conversations and voting in favor of doing things as they have always been done. Through their research and in offering "Recruit the Right Board" as a guide, Brown and Engle disrupt and redirect unhealthy cycles in the board room to get boards on the right track and encourage competent board nominations to ensure that association processes and decisions are cultivated by the right hands.

# FORUM: In "Recruit the Right Board," you focus on/discuss exemplary boards that are models for others, and boards that need optimization that you use for your case studies. How did you choose the boards for your study?

**Brown:** There were several processes for selecting the associations to work with. Mark has a lot of relationships with people who he knew needed help in recruitment selection. He has observed and identified which boards are outstanding. The main question we asked ourselves was, "Are these boards exemplary?"

We wanted a variety of boards as our samples: trade, healthcare, national, international, regional and state-based associations. When it came down to it, we had two categories of these boards: the majority group of boards with comprehensive processes and the minority group who do unique things in that model.

**Engle:** We asked our network of lawyers and consultants to name some organizations that have advanced the makeup of their boards in significant ways. We then vetted the list through questionnaires and ultimately screening calls. The research team ensured we had a balance of trade and professional; state, national and international; various industry; and profession domains. The case studies were not qualified as high-performing. The quantitative analysis did use a marker to determine high-performing boards based on a set of responses to key board functions as identified by BoardSource prior research.

# FORUM: What are the characteristics of some of the exemplary boards that you highlight in "Recruit the Right Board" as case studies?

**Engle:** The boards we found to be instrumental in our research had common trends of transparency, diversity,

cultivation, anticipatory behavior and identifying core competencies. While facing board election and re-election cycles, these associations would look at their strategic plan, identify which competencies already existed on the board to help achieve the strategic plan and then actively seek out nominees to fill the gaps. Then the associations would communicate which core competencies were required for the board selection process, helping minimize the potential for incompetent candidates as well as empowering more competent candidates to apply. The associations would also ascertain that the process was transparent, not nebulous, and would seek out more diversity in the nominees to account for desired competencies as well as assure a more accurate representation of the association members. Finally, the associations had a leadership development committee that would recruit, develop and orient leaders, as well as create succession plans. These boards focus on both the current and future needs of their associations.

# FORUM: "Recruit the Right Board" builds on your previous groundbreaking ASAE Foundation governance research. What makes the research groundbreaking?

**Engle:** One fundamental shift we outline is the shift to noncompetitive elections for leadership and why. As associations compete in a new environment, the old methodology for selecting leadership may not serve the organization well for the future. AMC Consulting Services does considerable work with medical and legal associations. The competition for members and attendees in medical societies and bar associations has increased from private enterprise, institutions and other nonprofit organizations. No longer do these associations "own the field" for education and community.

The skillsets we need in the board room to advance programming and initiatives for the field today are very different than they were 5 and 10 years ago. Both the case studies and the samples are particularly valuable in the book.

# FORUM: Can you elaborate further on why board effectiveness is so important? What downsides do you see of ineffective boards?

**Brown:** Board effectiveness is important because the functions of governance (oversight, strategy and support) facilitate or inhibit an executive's ability to operate the association. Providing good insight and guidance for the future of an association is incredibly valuable for managers. Similarly, facilitating healthy external relationships can mitigate barriers that executives might confront. The legitimacy of board members can be quite influential among key stakeholders, and the process of getting good people only builds that legitimacy and informs the decisions that they make.

# FORUM: Why is this research necessary for association professionals? Rather, what information void does it fill?

**Brown:** Having a good group of people who can serve, govern and fulfill those responsibilities and functions, irrespective of your industry, makes a difference for how these organizations work. It's about having the right people in the room to make decisions and facilitate a process to guide the organization on a strategic level, and this idea of stewardship and leadership at the board level is particularly pressing in associations and everywhere. If we don't have these people, it can create a number of issues and challenges. Before this study, we hadn't articulated the procedures and operations of how you build this stuff out. In this space, in this topic, this is the first taxonomy of its kind, and so it has a high value proposition.

# FORUM: If an association's board is not performing well, where is the first place they should start?

**Engle:** They should consider a board self-assessment to identify where they are not performing well and use the evaluation matrix in the book to determine if they have the right competencies and experience/demographics represented in the room to advance decision making for the organization.

# FORUM: If you had to choose one key takeaway from this book, what would it be?

**Engle:** My one takeaway is that there is so much you can do to optimize your organization when you answer these questions: Can your organization make decisions as fast as the marketplace or profession in which you serve? Is your board made up of individuals capable of advancing key decisions in a timely manner that balances opportunity with risk?

# FORUM: What are your predictions for the future of board governance, based on vour research?

**Brown:** I honestly don't see much shift in the way organizations think about governance. Boards are inherently a risk-averse

structure (see Joern Hoppmann's article "Boards as a Source of Inertia" in the Academy of Management Journal 62(2): 437–468). The boards tend not to be open to shifts in structures, and structures are fairly homogeneous. Boards in one organization act and are structured a lot like boards in other organizations. Don't get me wrong, there are variations in every group of board members. Each have their own nuances and organizations have unique histories. Furthermore, we (experts) often give advice that seeks conformity and alignment with "best" practices. Most board members are unwilling to accept major structural changes or modifications. So, what is my prediction? More of the same, well-intentioned individuals trying to make sense of complex opportunities and challenges with limited time and often limited information.

**Engle:** Our research also supports Will's comment. A big concern we are seeing is boards' lack of capacity to change their decision-making model in order to operate in a heavily competitive market. Outdated governance models do not support the capability to make real-time decisions to take advantage of market opportunities and respond to threats in an appropriate window of time. Many models value "structure over substance," seek broad input to inform decisions, and seek tight or small bodies to make decisions.

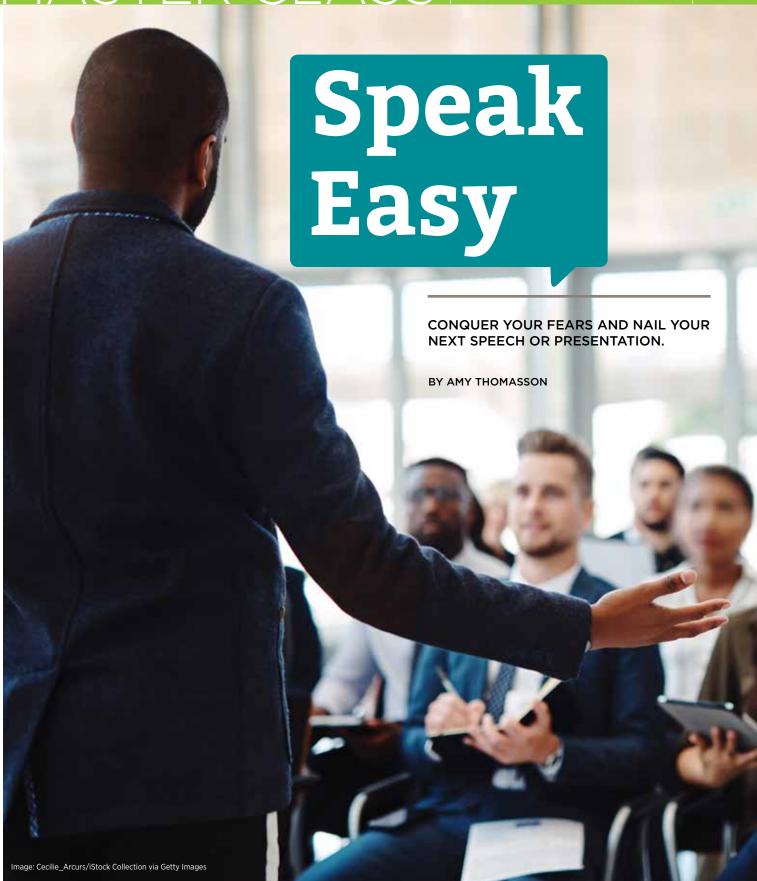

While public speaking may not have the dubious distinction of being the most common fear, it still ranked highly enough on Chapman University's annual "Survey of American Fears" to beat out kidnapping, zombies and even the prospect of an apocalypse. However, unlike battling a horde of zombies, delivering a speech or presentation is a challenge you have likely faced and will continue to encounter throughout your career. As association management professionals, we must also address unique demands of not only conquering our public speaking fears, but conveying compelling stories that move our members, volunteers and staff teams to action. Luckily, there are simple steps you can take to move from a novice to a polished speaker, effectively tailor your story to your audience and appropriately address feedback. Your peers are here to tell you how.

# **Getting Started as a Novice Speaker**

### 1. Nerves are normal.

According to Mark Twain, "There are two types of speakers: those who get nervous and those who are liars." Anyone who has had the privilege of meeting the indomitable Jacqualine Price Osafo, membership and development director, Water Quality Association, would be surprised to find that nerves are still part of her pre-presentation equation. Yet she has learned to harness that energy productively. Price Osafo says, "The key is getting some of the nervous energy out of your body prior to stepping in front of an audience. I am obsessed with the Wonder Woman pose for confidence. One must stand in the Wonder Woman—or for men, Superman—pose for five minutes. The purpose of the pose is to increase your self-confidence. I learned about this pose in Shonda Rhimes' 'Year of Yes' and Amy Cuddy's TED Talk, 'Your Language Shapes Who You Are.' My second act of preparation is to exercise my mouth and body by singing one of my favorite tunes or dancing it out to a favorite song."

# 2. Observe and apply your learnings.

Scott Oser, President, Scott Oser Associates, partners with associations to deliver customized solutions and strategic expertise. This line of work has resulted in exposure to countless speakers, presenters and facilitators, enabling him to learn by watching others. "I have watched speakers within

the association space and outside of our space to see what they do well and what I can incorporate

into my presentations," he says. While observing and learning from the successes and stumbles of other speakers is important, Oser also emphasizes making your presentations your own. "Be confident and make sure you have your own presentation style. Audiences can sense when

speakers are unsure of themselves. Speakers get selected based on their knowledge and experience, so let that shine through."

# 3. Prepare to go off script.

Jon Kinsella, senior marketing strategy manager, Association Headquarters, has also spent his career serving an array of association clients. The needs of his clients are as varied as the members they serve, which has afforded Kinsella the opportunity to speak at annual meetings, deliver online educational programs and more. Since he functions as a representative of the organization he is serving, Kinsella has learned that advance preparation is critical to success. "Confidence comes from preparation. Being a subject-matter expert on digital marketing has given me the confidence to pivot off my script and venture into spontaneous streams of consciousness that have produced some of my most compelling content," Kinsella says. "The level of presence that confidence produces helps me get out of my head and pay attention to my audience. From there, I can key in on what they are responding to and what isn't hitting home, which helps determine what to expand upon and what to quickly glide over."

Once you've moved from nervous novice to comfortable communicator, vou'll next want to tackle adjusting your presentation based on your audience.

# Personalizing Your Message and **Delivery Style for Your Audience**

# 1. Understand the organization.

Oser says, "I always try to learn as much as I can about who the audience is and tailor my focus accordingly. When it comes to association audiences, there are many things that can be

triggers for changes in my message, but a few key ones are individual membership versus trade associations, level of experience and size of the organization. Based on that information, I will go more strategic versus tactical, as well as tweaking my talking points to be applicable to a larger portion of the total audience."

# 2. Know who is in the audience.

"If possible, I ask for a registration list ahead of time. I look at registrants' titles and associations. I often visit participants' websites to evaluate services related to the presentation. For those times when this information is not available, I try to have an in-depth conversation with the event organizer. I also take a quick poll related to the topic of discussion, experience level and association tenure," says Price Osafo. This polling methodology can be especially useful when presenting to a new audience, such as when she recently presented to her first international audience at the African Society of Association Executives (AfSAE).

# 3. Make your content applicable and actionable.

"In a field that changes as quickly as digital marketing does, theoretical knowledge must be supported by practical use of action plans. This is always top of mind when I prepare for a speaking engagement, whether the audience is small business owners or association executives," Kinsella explains. "Context is just as important as content. Each audience has different pain points and challenges, so I make a point to provide real-world, tactical case studies specific to their day-to-day that complement the overarching theory or strategy."

Finally, a good presenter knows that a presentation isn't a one-way communication. Your audience is constantly communicating with you, and there are some guick ways to understand what they're saying and make simple adjustments to reflect their needs.

# Recognizing and Responding to Audience Feedback

# 1. Pay attention to nonverbal cues.

"I pay attention to facial expressions: A confused look translates to the need to adjust my explanation. The body language of your audience may be an indication of boredom. This is a great opportunity to get the audience engaged and/or add humor to presentation. Sometimes, I will call myself out and say, 'I'm not capturing your attention,' which serves as a cue to reengage. Audience engagement is key," says Price Osafo.

# 2. Ask questions before the presentation.

"If I don't know who is going to be in the room before I arrive, I often begin my talk by asking a few questions about the audience or their organizations. If there is a large percentage of attendees from a particular segment or category, I will tweak my presentation points if possible," Oser says.

# 3. Wrap up with more questions and answers. Kinsella says, "Audience feedback and Q&As are

always encouraged because they provide insight into what topics I need to dive deeper on and

what isn't working. They also provide me with ideas for future topics and spin-off presentations, which helps me constantly alter and enhance my offerings."

Although speaking up in the form of a speech or presentation may not be your preferred work or volunteer assignment, with practice and these tips, you can make the experience more pleasant and effective. At minimum, it'll be less intimidating than a vampire, active volcano or shark-infested waters. If all else fails, I'll leave you with my personal mantra whenever my pre-speech discomfort is setting in: "This is what growth feels like." 🖪

"For me, Welcoming Environment® means you can be where you are without fear of meeting bias; you are evaluated on what you can control—like effort and mindset—and not what makes you, you."

This is how Tyler Eble, vice president at Association Development Solutions, began the Welcoming Environment® Roundtable session at Holiday Showcase 2019. The roundtable session was

just one of many Welcoming Environment® initiatives at this year's event. From a special registration area for first-time attendees, to a ribbon wall that included pronouns and self-expressive adjectives, the event put inclusion at the forefront.

Back at the roundtable session, professionals from various associations discussed topics relating to leadership and communication, member and attendee engagement, and psychological safety. Several attendees noted that their association leadership and boards have created committees to address diversity and inclusion, but that the work has been stagnant. It seems that most associations want to create a Welcoming Environment®, but few know where to start.

If your organization is struggling to make formal strides toward inclusion, look at Association Forum's Welcoming Environment® Resource Kit (association forum.org/welcomingenvironment). The kit includes definitions of a Welcoming Environment®, best practices and real examples of inclusive work environments in the association profession.

Nicole Blankenship, MBA, CAE, is the director of chapter and district relations for the American Academy of Pediatrics (AAP). She attended the Welcoming Environment® Roundtable at Holiday Showcase looking for ideas to strengthen the work that the AAP is doing in this area.

The AAP Board of Directors formed the Board Committee on Equity in October 2019. This committee is charged with overseeing the implementation of recommendations from the Diversity and Inclusion Task Force and the Bias and Discrimination Task Force. "The AAP feels it is important to look at the root causes of health disparities, including educational inequities, poverty, adverse childhood experiences, food insecurity, racism, lack of access to quality health care, social determinants of health and environmental threats," Blankenship says in an email.

She also notes that the AAP plans to address equity in education, policy, advocacy, research and clinical practice support, and will implement recommendations at every level of the organization. "We recently introduced new policies on racism and immigration to help advance these efforts," Blankenship writes.

The efforts put in place by the AAP echo some-

thing discussed at Holidav Showcase—a Welcoming Environment® has to come from an organization's board and be intentionally integrated into every aspect of the organization.

### Leading by Example

FORUM MAGAZINE REMEMBERS THE CONTRIBUTIONS OF JOHN GRAHAM IV, AN INSPIRATION TO MANY.

> John Graham IV. FASAE, CAE, former President and CEO of ASAE, was a mainstay in the association world for more than 40 years. His recent passing, after an extended battle with cancer, has saddened the greater association management community.

> Graham joined ASAE in August 2003. In his time with the organization, he oversaw incredible growth, more than doubling ASAE's membership, along with leading the charge on a variety of innovative and progressive initiatives that would position ASAE as a true leader in the industry.

> Prior to his tenure with ASAE, Graham was part of the American Diabetes Association (ADA) for 24 years, serving as their CEO for the last 13 of those. He also worked for the Boy Scouts of America for nine years before joining ADA. In May 2015, he was honored and recognized as a Distinguished Eagle Scout for his contributions to the organization.

### A True Advocate

Graham's résumé only scratches the surface of his contributions and dedication to the industry. His passion for his initiatives helped define his goals for the community: bringing people from all backgrounds together and showing the world why associations are so important to society.

Most notably, Graham invested heavily in ASAE's Diversity Executive Leadership Program (DELP). The mission of this program is to support individuals from underrepresented identity groups in their advancement into the ranks of association management leadership. The two-year program has many goals, most notably:

- To provide individuals from identified underrepresented groups in the association community (people of color, those in the LGBTQ+ community, people with disabilities) with support, access and opportunities for leadership.
- To provide the association community with increased access to a diverse pool of talented leaders.

Graham spent years growing the program, according to Pat Blake, FASAE, CAE, CEO, Heart Rhythm Society. She remembers his work with DELP as influential. "The program was near and dear to John's heart," she says. "Every initiative needs a champion who is passionate about its success and



longevity. The DELP program embodies diversity, equity and inclusion, and John's efforts certainly contributed to its continued success."

Michelle Mason, FASAE, CAE, President and CEO. Association Forum, echoes these sentiments, saying Graham's work provided opportunities for those who were ignored previously. "The DELP program has set the stage for so many professionals to go on to achieve and accomplish their goals in the industry, many of which would not have been realized if not for the work of John. He knew this, and today we are dedicated to creating a welcoming environment for every association professional."

Graham's intense focus on diversity and inclusion was key to the sentiment picking up steam in the association world. "You can't take your eye off the ball," Blake adds. "John knew that, and that's why I think he'll always be remembered for his efforts to make association management accessible for all."

Graham was also invested in the expansion of associations both nationally and internationally. "He believed that associations touch so much of the fabric of society," Mason says. One prime example is his Associations Advance America campaign, which later evolved into The Power of A initiative that we see today. The message was simple yet extremely important: Associations help advance workers' skills and create new employment opportunities, in turn making America and its economy stronger.

His advocacy of associations across many channels, including legislatively, provided a launchpad for the industry to become recognized as a valued contributor to the economy and workforce.

"John believed that the association profession made a difference," Blake says. "Both nationally and internationally, he thought that because associations exist and because of the work we do, the world was a better place."

### **Positive Influence**

Throughout his career, many association professionals credit Graham with impacting both their professional and personal lives. For Mason, meeting Graham changed the trajectory of her career. "When I first met John, I was on staff with ASAE as an associate manager of research. Having the exposure to a leader like John so early on in my career was really a milestone moment for me," she says. "He was very professional, engaging, smart and definitely passionate about his work in the nonprofit sector."

For Mason and many others. Graham was an influential mentor, helping shape the minds and careers of countless association professionals. Paul Pomerantz, FACHE, FASAE, CEO, American Society of Anesthesiologists, notes that Graham helped him start his second career in the association management world. "I was at my first association job and was trying to figure out which way was up," he says, "and he was incredibly warm and friendly. As the new guy in the industry, I was nervous. But he made me feel right at home."

Blake says that she didn't ask for much advice from Graham over the years, but there came a point when she began to think about a scenery shift in the industry. "The first person I called was John," she says, "and I told him I didn't even know where to begin. He told me to start 'putting a bug' in a couple of well-placed people's ears. Before I knew it, John had already done that for me, reaching out and helping me get the interview for the position I still hold today."

Not only was Graham's extensive network impressive, but his personality was contagious and set him apart from others in the field. "He had an engaging sense of humor and a very distinctive laugh," Pomerantz continues. "He was so concise and articulate. When he conceptualized an idea, he delivered it crisply, where you learned something from virtually everything he said."



### **Lasting Memories**

With the passing of such an influential figure, it's important to not let the personal, more intimate memories fade.

For Pomerantz, one lasting memory he has of Graham is the post-meeting or event extracurriculars, usually involving long and deep discussions over a few drinks at a bar. "He would always have the 'John Table,'" he remembers. "But it wasn't an exclusive table at all. Whoever was at that meeting or event was welcome."

More and more chairs would be added to the table, sometimes growing to as many as 20 attendees, all gathered around Graham, listening to his advice and striking up conversations about the intricacies of the industry. "He would always have his signature drink, a glass of Johnny Walker Red scotch—what I would call beginner's scotch," Pomerantz jokes. "He was usually the last one there, closing down the bar. But he'd always show up in the morning for the next session as sharp as a tack."

Graham's kindness stretched beyond the professional world, as Blake recalls. "My husband was diagnosed with cancer," Blake says, "and the first question John would ask me every time he would see me was, 'How is your husband doing?' That meant a lot to me. Of all the people that John knows, all the issues he hears about and all the personal information he gets told, he never forgot to ask. John always cared."

For Mason, the experiences she shared with Graham would never leave her. "We had moments where we were communicating as mentor-mentee, but we also had interactions where we were competing in the same market." she remembers. "I came out of those conversations much stronger as a result. Even in the moments when things were more tense, he was always teaching me how to be a better leader."

Graham was one of the true giants in the association management world. The memory of Graham will be a lasting one for all who spent time with him, and his influence will continue to impact professionals and the industry for years to come.

### Remembering a Legend

### THE ASSOCIATION COMMUNITY MOURNS THE PASSING OF RODERICK GEER, A RENOWNED EXPERT IN HIS FIELD.

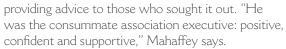
Past ASAE and Association Forum Chair Roderick L. Geer, CAE, passed away peacefully on Jan. 20 at the age of 92 after a long battle with Alzheimer's. He had a long-tenured career, with his most recent association CEO position at the Million Dollar Round Table in Chicago from 1971–1991. He was also President of the Chicago Society of Association Executives (CSAE), now Association Forum, in 1981-82.

Geer was an inspiration to many in the association management world, maybe none more so than Chris Mahaffey, MS, CAE, FASAE, Executive Director, American College of Foot and Ankle Surgeons. Mahaffey considered Geer his "mentor and second father."

"I first met Rod Geer in 1980 when he was on the Search Committee that hired me as the CSAE Executive Director, and he became my second boss as Board Chair in 1981," Mahaffey says. "Right out of the box, his professional guidance was amazing. I'd never experienced such support before."

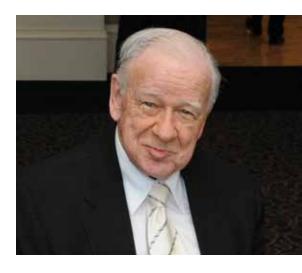
Known in the industry as dedicated and selfless. Geer won several awards for his work in association management. In 1983, he won the Association Forum John C. Thiel Distinguished Service Award. The honor is bestowed on unsung heroes in the field—behind-the-scenes volunteers who have a longterm, multifaceted volunteer record with the Association Forum

Geer was also known for his expertise in the field,



He was also a passionate Cubs fan; he had season tickets and always took colleagues to games. "He would invite two other CSAE'ers and myself to the games. We became known as the Wrigley Spirits," Mahaffey jokes. Celebrations wouldn't end with the last pitch, however, as he would always head to his favorite bar, Bierstube on Irving Park, for a few after-innings drinks.

But most importantly, Geer will always be remembered as influential to all he spent time with. "He mentored dozens of young executives, me included. Like Rod, I know they are all paying it forward to their own mentees," Mahaffey says. "He was the consummate role model for young association CEOs."

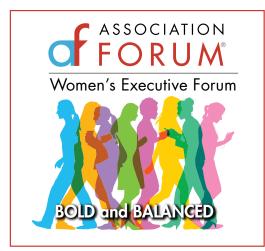
