The Teacher Evaluation System represents a shift in staff evaluation for the Franklin Township Community School Corporation. This handbook is a revision of the handbook that was in effect for the 2018 - 19 school year. It has been revised to accommodate changes in legislation and changes that make the evaluation standards a little more rigorous.

This document is not complete, nor do I believe it will ever be complete. It will continue to evolve whether that is through new legislation or through our own discovery methods. New ideas will be tested and challenged. We may find areas that need to be modified or removed. A periodic review of our evaluation system, like any good system needs to be included if it is to serve the school system well.

Indiana Teacher Evaluation: Public Law 90

The 2011 Education Agenda put students first by focusing on the individuals who most strongly influence student learning every day — teachers. Franklin Township teachers are hard-working and devoted to the success of every student. They deserve to be recognized for their hard work and devotion.

To do this, fair, credible and accurate annual evaluations are needed to differentiate teacher performance and to support professional growth. With the help of teachers and administrators, Franklin Township Community School Corporation has developed an evaluation system based not only on the State of Indiana model but crafted from the research and collaboration of many teachers (through the years) in Franklin Township.

According to the State of Indiana, every evaluation system must:

- **Be Annual**: Every teacher, regardless of experience, deserves meaningful feedback on their performance on an annual basis.
- Include Student Growth Data: Evaluations must be student-focused. First and foremost, an effective teacher helps students make academic progress. A thorough evaluation system includes multiple measures of teacher performance, and growth data must be one of the key measures.
- Include Four Rating Categories: To retain our best teachers, we need a process that can truly differentiate our best educators and give them the recognition they deserve. If we want all teachers to perform at the highest level, we need to know which individuals are achieving the greatest success and give support to those who are new or struggling.

The Teacher Evaluation System (TES) was created by a team of teachers and administrators who researched several models of evaluation systems; the Indiana RISE model, the systems proposed by Charlotte Danielson and Robert Marzano, and the work of the teacher evaluation model that had been developed by Franklin Township several years before which was also based on the research from Danielson.

Principal/Evaluators have and will continue to have training with instructional strategies, observation techniques, and appropriate professional development that will help improve inter-rater reliability. Administrative and leadership meetings are also opportunities to delve deeper into topics of evaluations for which the evaluators feel they need assistance.

Categories of Teachers

Teachers will be grouped as follows:

- Beginning Teachers (1 2 years of experience) and New Teachers to the District This group of teachers will receive four observations, all long, one each quarter, two (2) announced and two (2) unannounced, one (1) formal and three (3) informal so no lesson plans required.
- Experienced Teachers (not new to the district) All teachers employed by the FTCSC will be observed two times each year. Each teacher will receive a short/informal evaluation (15 20 minutes) and a long/formal evaluation (50 60 minutes). There will a pre-conference meeting between the administrator and the teacher. Within ten (10) days of the pre-conference the administrator will complete the observation.
- The two groups above will be further divided, those who work with state standardized testing (ELA and Math) and those who do not. *

Teacher Groups:

Group 1 - Teachers that teach grades K-3 (do NOT teach grades 4-8 ELA and/or Math) and all grades of the following SLP's, resource teachers, related arts teachers, CIP teachers, Social Studies or Science.

- Teacher Evaluation Rubric = 70%
- Student Growth = 15%
- o Goal = 10%
- School Grade = 5%

Group 2 - Teachers who teach grades 4-12 grade ELA and/or math are required by law to use part of the pie for state standardized testing growth. FTCSC has decided to dedicate 5% for state standardized testing and 10% for local assessments.

- Teacher Evaluation Rubric = 70%
- State standardized testing = 5% (Student Growth Total = 15%)*
- Local Assessment (Items such as Airway) = 10% (Student Growth Total = 15%)
- o Goal = 10%
- School Grade = 5%

Group 3 - Teachers who have non-teaching assignments. This includes instructional coaches, media specialists, counselors and school psychologists.

- Teacher Evaluation Rubric = 85%
- Goal = 10%
- School Grade = 5%

- Teachers who fall into a category other than classroom teacher will meet all the same requirements but will be observed with a different rubric.

In addition:

- Each teacher will write a goal that follows the SMART goal format and is tied to building and/or district goals.
- Each teacher will submit student growth data determined through an assessment. If the teacher instructs in a grade or content area in which state provided assessments, the state assessment must be used.
- Each teacher will have the school grade as designated by the Indiana
 Department of Education as part of their summative evaluation score.

All teachers will be evaluated every year. All teachers will participate in a pre-conference with their evaluator as required by law. Evaluator will hold observation within ten (10) days of the preconference.

All evaluations must be completed by the evaluator, reviewed by the teacher, and submitted by the building principal to the Human Resources Department.

If a teacher does not agree with the evaluation/assessment by the administrator/evaluator, the teacher may write a rebuttal statement that will be included with the evaluation when submitted to the HR Department. The teacher may additionally request and be granted a meeting with the Chief People Officer.

Performance Level Ratings

Each teacher will receive a rating in one of the four performance levels:

- Highly Effective: A highly effective teacher consistently exceeds expectations. This is a
 teacher who has demonstrated excellence in locally developed and selected
 competencies reasonably believed to be highly correlated with positive student learning
 outcomes. The highly effective teacher's students, in aggregate, have generally
 exceeded expectations for academic growth and achievement based on guidelines
 suggested by the Indiana Department of Education.
- Effective: An effective teacher consistently meets expectations. This is a teacher who has consistently met expectations in locally developed and selected competencies believed to be highly correlated with positive learning outcomes. The effective teacher's students, in aggregate, have generally achieved an acceptable rate of academic growth and achievement based on guidelines suggested by the Indiana

Department of Education. It should be noted that the committee that created this document suggested that most teachers "live" in the world of effective teaching and will occasionally "dance" in the world of highly effective.

- Improvement Necessary: A teacher who is rated as improvement necessary requires a change in performance to meet expectations. This is a teacher who has been determined to require improvement in locally developed and selected competencies reasonably believed to be highly correlated with positive learning outcomes. In aggregate, the students of a teacher rated improvement necessary have generally achieved a below acceptable rate of academic growth and achievement based on guidelines suggested by the Indiana Department of Education.
- Ineffective: An ineffective teacher consistently fails to meet expectations. This is a
 teacher who has failed to meet expectations in locally developed and selected
 competencies reasonably believed to be highly correlated with positive learning
 outcomes. In aggregate, the students of a teacher rated ineffective have generally
 achieved a below acceptable rate of academic growth and achievement based on
 guidelines suggested by the Indiana Department of Education.

Students who are in an ineffective teacher's classroom will be carefully monitored by the principal to ensure that they are not assigned to an ineffective teacher the following year. In the case that a student's assignment would be unavoidable, the principal will contact the parents of the student(s) and inform them of the teacher's status and what type of support will be offered by the school corporation to provide opportunities for their student(s) to be successful.

Negative Impact

IC 20-28-11.5-4(c)(6)

A provision that a teacher who negatively affects student achievement and growth cannot receive a rating of highly effective or effective

511 IAC 10-6-4(c)

Negative impact on student learning shall be defined as follows:

- (1) For classes measured by statewide assessments with growth model data, the department shall determine and revise at regular intervals the cut levels in growth results that would determine negative impact on growth and achievement. Cut levels shall be published by August 1.
- (2) For classes that are not measured by statewide assessments, negative impact on student growth shall be defined locally where data show a significant number of students across a teacher's classes fails to demonstrate student learning or mastery of standards established by the state.

Student Not Instructed by an ineffective teacher

School corporation will notify parents in writing if a student is effected by an ineffective teacher as defined below:

IC 20-28-11.5-7

- (c) If a teacher did not instruct students in the school year immediately before the school year in which students are placed in the teacher's class, the teacher's rating under this chapter for the most recent year in which the teacher instructed students, instead of for the school year immediately before the school year in which students are placed in the teacher's class, shall be used in determining whether subsection (b) applies to the teacher.
- (d) If it is not possible for a school corporation to comply with this section, the school corporation must notify the parents of each applicable student indicating the student will be placed in a classroom of a teacher who has been rated ineffective under this chapter. The parent must be notified before the start of the second consecutive school year.

Evaluation Plan Discussion

School corporation will present to the school board at a public board meeting and discussed with the teachers' association at central discussion per Indiana Code below:

IC 20-28-11.5-4

- (e) This subsection applies to plans applicable to annual performance evaluations for school years beginning after June 30, 2015. The plan must:
- (1) be in writing; and
- (2) be explained to the governing body in a public meeting; before the evaluations are conducted. Before explaining the plan to the governing body, the superintendent of the school corporation shall discuss the plan with teachers or the teachers' representative, if there is one. This discussion is not subject to the open door law (IC 5-14-1.5). The plan is not subject to bargaining, but a discussion of the plan must be held

The Evaluation Cycle

The Evaluation Process contains 4 measures of assessment. Each assessment will be weighted on a percentage basis to the whole. The performance rubric which will include the observations performed by an evaluator will count for 70% of the final (summative) score. Student growth (assessment) is 15% of the total. The final two are goal setting (performance) and school grade worth 10% and 5% respectively.

Each measure is scored individually and then calculated into a total final score. This is the score that determines the final effectiveness rating. If a teacher does not score in the highly effective or effective category, the teacher will not be eligible for a pay increase the following year.

Teacher Groups:

Group 1 - Teachers that teach grades K-3 (do NOT teach grades 4-8 ELA and/or Math) and all groups of the following: SLP's, resource teachers, related arts teachers, CIP teachers, Social Studies or Science.

- Teacher Evaluation Rubric = 70%
- Student Growth = 15%
- o Goal = 10%
- School Grade = 5%

Group 2 - Teachers who teach grades 4-12 grade ELA and/or math are required by law to use part of the pie for state standardized testing growth. FTCSC has decided to dedicate 5% for state standardized testing and 10% for local assessments.

- Teacher Evaluation Rubric = 70%
- State standardized testing = 5% (Student Growth Total = 15%)
- Local Assessment (Items such as Airway) = 10% (Student Growth Total = 15%)
- o Goal = 10%
- School Grade = 5%

Group 3 - Teachers who have non-teaching assignments. This includes instructional coaches, media specialists, counselors and school psychologists.

- Teacher Evaluation Rubric = 85%
- o Goal = 10%
- School Grade = 5%

A. Goal = SMART Goal created in September.

Goals get a little confusing. There are technically two types of goals now. SMART Goal and Growth Goal. Definitions and weighted scores listed below.

SMART Goal-10% of Final Score

- 4 points=exceeds the stated measurement in the goal.
- 3points=meets the stated measurement in the goal.
- 2 points=did not meet the stated measurement in the goal, evidence is provided. The teacher can provide evidence as to why the goal was NOT met. Teacher can provide evidence of steps taken by the teacher to make the goal.
- 1point=did not meet the stated measurement in the goal, no evidence provided.

B. Student Growth- For group 1 teachers this is 15% of your evaluation and for group 2 teachers this is 10% of your evaluation. A student growth goal must be data driven and students must show growth. SO—If you wrote your personal goal to be a data driven SMART goal, then you've already taken care of this. If your SMART goal was not data driven, you will need to write a second growth goal. For the growth goal all you need to do is show student growth. If students grow 1%, you've met the student growth goal.

Student Growth Score Weighted

- 4 points=Yes, the results of the assessment shows growth.
- 0 points=No, there was NO growth indicated from the data.

C. Teacher Performance Observations: Minimum of 1 short and 1 long (informal/formal). If the evaluator or teacher want additional observations that can be done but only one of each can be submitted for the evaluation.

Short=15-20 minutes unannounced

Long= class period or duration of content lesson (approximately 60 min)

Preconference required- discuss goals or to discuss class/content dynamics Evaluator will hold observation within ten (10) days of the preconference.

<u>Observation</u> - unannounced but shortly after the preconference. After observation, submit the lesson plan in PIVOT. Your administrator may ask for further documents to be uploaded into PIVOT. One example of each subcategory listed is helpful, but not required.

- Domain 1 Instruction 40%
- Domain 2 Classroom Environment 40%
- Domain 3 Preparation and Planning 10%
- Domain 4 Professional Responsibility 10%

Observation of Teacher Practice: Questions and Answers regarding the process

How will my proficiency in the four categories be assessed?

Your proficiency will be assessed by a primary evaluator who will be either your principal or your assistant principal. The primary evaluator will evaluate you [throughout the year] during one formal (long) evaluation and one informal (short) observation.

What is the role of the primary evaluator (principal or assistant principal)?

Your primary evaluator is responsible for tracking your evaluation results and helping you to set goals for your development. The primary evaluator will hold a pre-conference with the teacher. The primary evaluator will observe in your classroom. Goals and student growth will also be monitored by the primary evaluator. Once all data is gathered, the primary evaluator will look at information collected by all observations throughout the year and determine your summative rating. He or she will meet with you to discuss this summative rating in a final conference.

How are the evaluators trained (principal or assistant principal)?

Primary and secondary evaluators are trained annually through district professional development on the teacher evaluation system, any changes to the system, timeline, or law as well as inter-rater reliability.

What is a secondary evaluator?

A secondary evaluator may perform short observations as well as work with teachers to pass along information to the primary evaluator. A secondary evaluator does NOT determine the final rating of a teacher – the summative evaluation.

What is a formal or long observation?

A formal/long observation will be more extensive than a short observation. This could be one period in the secondary level or may be 50-60 minutes to cover an area such as math at the elementary level. There will be only one formal observation each year.

What is an informal or short observation?

A short or informal observation is scheduled to last between 15 - 20 minutes. There are no conferencing requirements around a short observation. There is only 1 mandatory short observation scheduled as part of the evaluation cycle. However, a primary or secondary evaluator may conduct a short observation at any time during the year.

What is the purpose of a short observation?

A short observation gives an evaluator to see a snippet of a normal classroom day. The evaluator may observe classroom management techniques, posted objectives, student engagement, instructional or technology practices being used.

Are there mandatory conferences that accompany a formal observation?

A pre-conference is now required by law. The pre-conference can include a check for understanding on how the evaluation process works, goal discussion, or any other piece of the evaluation conference. Any pieces of information that the evaluator would like to see during the conference (lesson plans, grade book, etc.) must be requested of the teacher prior to the pre-conference.

A post-conference is required after an observation. The evaluator and the teacher should share the results of the observation.

What support is available for those teachers who are in need of assistance with their performance?

These teachers will be observed numerous times. The primary evaluator will determine if the teacher should be placed on a professional development support plan. This plan will be for all teachers that are rated improvement necessary or ineffective.

How will my observations be scored?

Both long and short observations are times for evaluators to collect information. There will be no summative rating assigned until all information is collected and analyzed at the end of the year. However, evaluators are expected to provide specific and meaningful feedback on performance following all observations.

Domains 3 and 4 are difficult to observe. How will I be assessed in those domains?

Evaluators may need to collect material outside of the classroom to assess these domains. Teachers should be proactive in demonstrating their proficiency in these areas. However, evidence collection in these two domains should not be a burden on teachers that detracts from quality instruction. Evaluators should not ask for these documents unless there is a question of performance. Examples of evidence for these domains may include but are not limited to:

Domain 3 – Planning and Preparation

Lesson and unit plans, planned instructional materials and activities, assessments, and systems for record keeping.

Domain 4 – Professional Responsibility

Documents from team planning and collaboration, call-logs or notes from parentteacher meetings, and attendance records from professional meetings or school based activities.

How does an evaluator take notes?

During an observation, an evaluator will take evidence-based notes, writing specific instances of what the teacher said and the teacher did in the classroom. The evidence that evaluators record during the observation should be non-judgmental, but instead reflect a clear and concise account of what occurred in the classroom.

The evaluator will take these notes and match them to the appropriate indicators on the rubric in order to provide the teacher with rubric-aligned feedback. Teachers will be able to see the scores, comments, and interim scores after observations. This will be achieved through a software system that evaluators will be using to match indicators and evidence.

What is professional judgment?

Assessing a teacher's professional practice requires evaluators to constantly use their professional judgment. No observation rubric, however detailed, can capture all of the nuances of how teachers interact with students. And synthesizing multiple sources of information into a final rating on a particular professional competency is inherently more complex than checklists or numerical averages. The rubric provides a framework upon which evaluators can base their professional judgment.

Professional judgment should also consider the ways and extent to which a teacher's practice grew over the year, a teacher's response to feedback and support, how a teacher adapted his or her instruction to their current students, and many other appropriate factors that cannot be directly accounted for in the rubric before settling on a final rating. In short, evaluators'

professional judgment bridges the best practices set forth in the rubric and the specific context of a teacher's school and students.

Is the rubric the only measure for which a teacher is scored?

The summative (final) evaluation will consist of 4 components only one of which is the rubric. Each of the components will carry its own weighted value. All four components are reviewed in the pages that follow. Their specific percentage value is also given.

Franklin Township Community Schools – Teacher Evaluation System Rubric

The Teacher Evaluation System Performance Rubric consists of four domains, stated competencies, the knowledge of an effective teacher, and the disposition (attitudes/beliefs) of an effective teacher. This part of the evaluation process counts for 70% of the overall summative rating. Within the rubric the first two categories (competencies) are Instruction and Classroom Environment. These two are weighted at 40% each of the total score. The remaining two, Planning and Preparation and Professional Responsibility, are weighted at 10% each.

Each category begins with a description of an effective teacher followed by the individual indicators for each competency.

Category 1 - Instruction

- **Knowledge** An effective teacher
 - has a deep understanding of the state standards and the corresponding skills, the strategic plan, and the district approved curriculum
 - understands the processes of reading, writing, and problem-solving related to their subject area
- **Disposition** An effective teacher
 - o values real world applications as an integral part of the curriculum
 - appreciates the integrations and influence of the state standards, the strategic plan, and of the curriculum on student learning
 - strongly believes in the importance of reflection and dialogue related to developing and modifying the curriculum

Competencies

- Best practices and strategies.
- Demonstrating flexibility, responsiveness, and checks for understanding.
- Differentiating instruction for students.

1.2 Competency Demonstrating Flexibility, Responsiveness, and Checks for Understanding

The teacher monitors understanding to inform instruction and makes necessary adjustments to instruction.

2.1 Competency Creating a Culture of Respect, Rapport, and Collaboration

The teacher creates a culture where students understand and abide by a set of established expectations and are aware of the rewards and consequences of their actions. (It is understood some students may not have the prerequisite skills necessary to fully engage in content even though the teacher adjusts instruction to accommodate the skill level of the learners.



Franklin Township Community Schools - Student Growth (Assessment)

Effective teachers have learning goals for their students and use assessments to measure their progress. For those who teach 4th through 8th grade Math or ELA, information on the extent to which students grow academically is provided annually in the form of growth model data (state standardized testing). Teachers of other grades do not have such information available.

This component of the evaluation process will be divided into two groups. Those who do have growth model data and those who do not have individual growth model data.

For subjects without state standardized testing data, student growth will need to be measured by another type of assessment. The hierarchy for such alternative assessments follows the following model.



The Student Growth (Assessment) will be 15% of the total summative score.

However, the Student Growth measure will be further divided. Grades; 4-8 have no choice but to include the State provided growth model data. For teachers in these grades, the state standardized testing data will only be 5% of the total 15%. The remaining 10% will follow the hierarchy as shown above.


Teachers in all other grades or content areas will use the hierarchy. It is possible, in some grades or content areas, that growth will be measured by a teacher developed assessment. Other teachers may use alternative assessments already used by the school district.

Franklin Township Community School Corporation – Goal Setting

Ten percent of the summative score is based on a goal that is written by the teacher. This goal must have a link to the district goals (strategic plan), the building goals, or the measure of student growth that has been selected.

The criteria for the goal is as follows:

- 1. It must be in the SMART goal format
- 2. It must be aligned as stated above.



* The teacher can provide evidence as to why the goal was not met. Examples could include a change in the size of the target group or other influences on the data.

The district goals for the 2018 - 2019 school year follow on the next page. Building goals will need to be secured from your building principal.

The final 5% of the overall summative score is based on the grade issued to the school by the IDOE. When the school grade is made available it will be used for performance evaluation purposes. The grade represents the team work and collaboration that is needed to promote the success of the students and the school.

The Teacher Support (Remediation) Phase

The Teacher Support Phase is for teachers, previously in the Professional Teacher portion of GPS, whose professional practice has diminished to a point, often times in a singular area, where professional support is essential. There are three clearly defined steps in this phase including:

- 1. Initial Administrative Notice and Support Phase
- 2. Collegial Support Phase
- 3. Intensive Administrative Intervention Phase

In the Initial Administrative Notice and Support Phase, the principal notifies the teacher in writing of the specific area(s) in need of improvement. The four domain rubrics defining professional practice serve as the resource to clearly define the area and level of professional practice expected from the teacher. At this time the goal-setting portion of the Professional Teacher portion of TEACHER EVALUATION SYSTEM is suspended, so the teacher, working collaboratively with the principal, can fully focus on the area(s) of interest. Resulting professional behavior aligned with the rubric and identified by the principal returns the teacher to the Professional Teacher status of TEACHER EVALUATION SYSTEM.

Insufficient progress results in the teacher moving to Collegial Support. This step expands the support to include teaching colleagues who, along with the principal, can serve as resources to support the teacher. The four domain rubrics of professional practice continue to serve as a guide for acceptable professional practice. Sufficient progress in this area results in the teacher returning to the Professional Teacher Phase, while insufficient improvement results in the teacher moving to the Intensive Support step of the Professional Teacher Support Phase. At this level a more comprehensive support team is put into place in an effort to more fully assist the teacher in meeting professional expectations. Sufficient progress at this step results in the teacher returning to the Professional Teacher Status, while insufficient progress results in a recommendation for non-renewal of the regular teaching contract. Classroom Walk-throughs for non-evaluative purposes are suspended during all steps of the Teacher Support.

Teachers in their first or second year of employment in FTCSC placed in the Teacher Support Phase may require greater assistance and guidance than is provided through that phase. In those cases, Domain 1 (Instruction) and Domain 2 (Classroom Environment) rubrics will be used to focus professional expectations; however, unsatisfactory performance in Domain 3 (Preparation and Planning) and Domain 4 (Professional Responsibilities) may result in a new teacher being placed in the Teacher Support Phase. The principal will enlist a mentor, in the case of a teacher with no teaching experience, and/or a colleague selected by the teacher to provide additional support. Teachers in the New Teacher Support Phase who are transitioned into the Teacher Support Phase receive only the Administrative Support and Collegial Support phases of assistance.

There may be times when a teacher in any portion of the TEACHER EVALUATION SYSTEM has unacceptable behavior. If this should occur, there are provisions for moving the teacher

immediately to Intensive Support Phase of TEACHER EVALUATION SYSTEM. Also, in cases of state statute or criminal law violations, the teacher may be suspended pending due process. All professional development received during the remediation phase will be used for Professional Growth Points for license renewal.

Initial Administrative Notice and Support Phase

The Initial Administrative and Support Phase of the Teacher Support section of the TEACHER EVALUATION SYSTEM, is to enhance communication between the building administrator and classroom teacher regarding FTCSC performance expectations. The singular goal of this process is to clearly communicate expectations and provide the necessary support to return the teacher to professional status or New Teacher Status for teachers in their first two years of service to FTCSC.

The process is as follows:

- The administrator notifies the teacher that he/she is moving into the Administrative Support of the Teacher Support Phase of TEACHER EVALUATION SYSTEM. The notification is in writing and includes the reasons for movement into Administrative Support. The flow chart defining the Teacher Support Phase is explained to the teacher.
- At the initial meeting, the principal and the teacher will design a plan which includes:
- 1. an established time line
- 2. a teacher support system
- 3. evidence required to demonstrate proficiency
- 4. teacher selects colleague(s) and those selected will provide feedback and guidance and not serve in an evaluative role
- When improvement to meet FTCSC professional expectations is noted, the administrator shares with the teacher in conference as well as in written form that the professional expectations have been met and the teacher is returned to Professional Teacher Status. The teacher can elect to continue to pursue the goal previously established or design another goal. No materials are placed in the teacher's personnel file as a result of this level of intervention.
- If improved performance is not noted by the administrator, the teacher is notified in a conference and in writing that the teacher is placed in the Collegial Support Phase of the Teacher Support. The flow chart defining the Teacher Support Phase is explained to the teacher.

Collegial Support Phase

The Collegial Support Phase of the Teacher Support section of TEACHER EVALUATION SYSTEM, is focused on expanding the number of resources in an effort to more fully assist the teacher in meeting professional expectations for educators in FTCSC. The process follows a

very similar format as the Administrative Support Phase, while expanding the amount of support to assist the teacher.

- At the conclusion of the Initial Support Phase, the administrator notifies the teacher that he/she is moving into the Collegial Support of the Teacher Support Phase of TEACHER EVALUATION SYSTEM. The notification is in writing and includes the reasons for movement into Collegial Support. The flow chart defining the Teacher Support Phase is explained to the teacher.
- At the initial meeting, the principal and the teacher will review the previous plan (listed below) adjusting strategies and expanding the support system.
 - 1. timeline established, including the next meeting date
 - 2. teacher action plan
 - 3. support system (Note: The principal may also recommend possible resources.)
 - 4. evidence required to demonstrate proficiency
- When improvement to meet FTCSC professional expectations is noted, the administrator shares with the teacher in conference as well as in written form that the professional expectations have been met and the teacher is returned to Professional Teacher Status. The teacher can elect to continue to pursue the goal previously established or design another goal. A written summary, including the development of the plan and corresponding information is placed in the teacher's personnel file as a permanent record of this level of intervention.
- If improved performance is not noted by the administrator, the teacher is notified in a conference and in writing that the teacher is placed in the Intensive Support Phase of the Teacher Support. The flow chart defining the Teacher Support Phase is explained to the teacher.
- Special note: Non-permanent teachers only participate in the first two phases of Teacher Support—Administrative Support and Collegial Support. If professional expectations are not met at the conclusion of the Collegial Support Phase, the teacher will be recommended for non-renewal of the teaching contract.

Intensive Administrative Intervention Phase

The Intensive Administrative Intervention Phase of Teacher Support is the most comprehensive level of support the school corporation provides to a teacher in need of improvement. This level of support is for a teacher who has not yet met professional expectations or fails to participate in either Administrative Support or Collegial Support. This level of support must be completed within the time frame established in IC.20-28-7 and will not last longer than one school year.

 At the conclusion of the Collegial Support Phase, the administrator notifies the teacher that he/she is moving into the Intensive Support of the Teacher Support Phase of TEACHER EVALUATION SYSTEM. The notification is in writing and includes the reasons for movement into Intensive Support. The flow chart defining the Teacher Support Phase is explained to the teacher.

- This level of support differs from Collegial Support in the severity of possible consequences, urgency, the level of resources and structured format.
- At the initial meeting, the principal, teacher, and the Intensive Support Team will review the previous plan (listed below) adjusting strategies and expanding the support system.
 - 1. timeline established, including the meeting dates and date for resolution
 - 2. teacher action plan
 - 3. support system (Note: The principal may also recommend possible resources.)
 - 4. evidence required to demonstrate proficiency
- When improvement to meet FTCSC professional expectations is noted, the administrator shares with the teacher in conference as well as in written form that the professional expectations have been met and the teacher is returned to Professional Teacher Status. The teacher can elect to continue to pursue the goal previously established or design another goal.
- If improved performance is not noted by the administrator, the teacher is notified in a conference and in writing that the teacher is being recommended for non-renewal of the semi-permanent/permanent teaching contract.
