Meeting Notes

LOGIN recap

- Had 6 board members in attendance (Brenda, Darius, Tom, Dave, Erin and Brian)
- IGDA Seattle Pro party on Tuesday night was great. Darius thought ~180 concurrent and ~300 pass through for the night.
- Takeaway for Chapters is to encourage them to try to hold events concurrently with local conferences

Minutes

- Jamil verified committee chairs were included
- Approved

April Budget (led by Tobi)

- Chapter escrow is something in each cities account
- Once chapters are chartered these can be removed from IGDA books
- Need to start looking into non-US chapters as each will need to be handled separately based on local laws
- Covered goals set from offsite for each committee to cover our \$50k budget deficit
- Cash flow projection is conservative as it assumes we do not meet the goals
- Tom requests a 12-month sliding report to help compare year over year how things are tracking

Leadership Forum Budget (led by Tobi & Jamil)

- LF Budget reviewed in the ESP meeting
- Have some minor updates Joshua is implementing
- Should return something with a more accurate portrayal
- Addressing the attendee revenue, potentially increasing the registration price, specifically with significant increase for non-member registrations
 - Suggestion was made around this and how it gets positioned to attendees (is it a members-only event, and thus impossible to attend without being a member?)

Membership Stats Update (led by Tobi)

- Had a significant (73%) drop in April year over year membership join/renewals
- Need to exceed projections by 1200 members to prevent the member drop
- Membership committee should "own" the membership projections and goals starting next month
- Some discussion around the membership number tracking and how the join/renewals come through vs total membership number

Committees Schedule / Auditing (led by Joshua)

- Need to ensure that schedule for committees is available to BoD
- Will have an events calendar for that
- Joshua will get this started and out Mon or Tues next week

Marketing Committee / Newsletter (led by Wendy)

- Starting on changes for June newsletter
- Have some people beginning to do work for the IGDA under paid roles
- Suggestion that we need to have governance setup the general rules for this type of thing in the future, but should approve on a short-term basis until that process is in place
- Current cost is \$1k/month, having these 2 individuals will reduce that cost to \$500/month
- Aside newsletter format and layout is being looked at by the committee
