Gait Disorder: Introduction

Gait disorder: Introduction

- Gait disorder is **very common** and affects **quality-of-life in the elderly**.
- Prevalence: **30%** in 60-97 years old population, **>60%** in over 80 years old population
- Cause: **75%** neurological causes / **55%** non-neurological causes
 - **29%** both neurological and non-neurological causes
- Impact: increase **fall** risk, decrease general condition and **life expectancy**

Elements for gait examination

● Spatiotemporal features

- Velocity
- Cadence
- Step length
- Asymmetry
- Step width
- Variability

● Lower extremity features

- Weakness, pain, stiffness, dyskinesia

● Additional features

- Upper extremities features
- Posture
- Other movements

● Episodic features

- Freezing of gait (FOG)



Proposed classifications and pitfalls

Classification	Examples	Pitfalls
Hierarchical	Lower level	Overlap in symptoms between different levels (eg, Parkinson disease patients might also display features of higher-level gait disorder)
	Peripheral skeletomuscular problems (arthritic, myopathic, and peripheral neuropathic gait)	Higher-level gait disorder entity is often abused with confusing nomenclature
	Peripheral sensory problems (sensory/vestibular/visual ataxic gait)	Higher-level gait disorder subtypes are difficult to recognize in clinical practice

Classification	Examples	Pitfalls
Anatomic	Frontal, cerebellar, etc	Gait patterns are not unequivocally attributed to a specific anatomic lesion (eg, wide-based gait might be caused by either frontal or cerebellar gait)
Etiologic	Vascular, neurodegenerative, etc	Ancillary investigations (eg, MRI) are required
Phenomenologic	Antalgic	Pathophysiology not taken into account
	Paretic/hypotonic	Classification is driven by a mixture of etiologic, anatomic, and clinical features

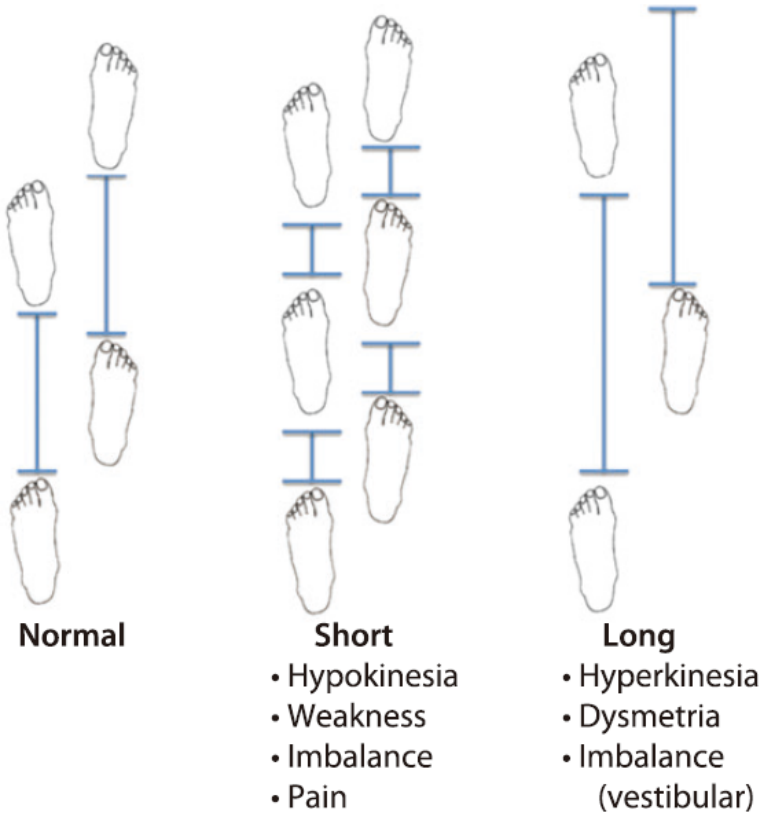

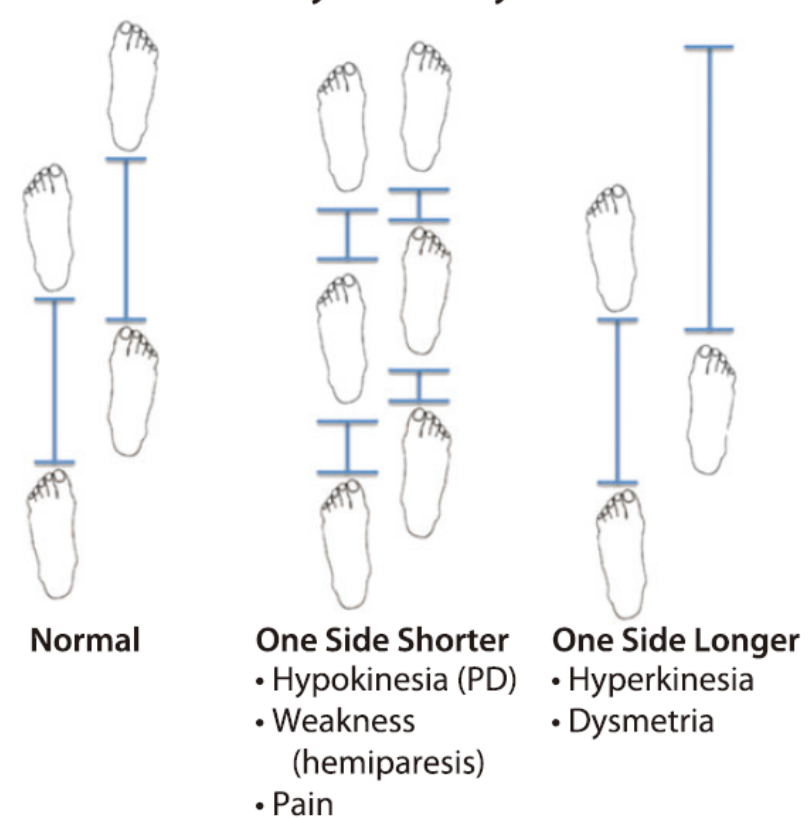
- Medical teaching programs typically take **classic clinical presentations** as the starting point and present students with a representative constellation of features that jointly characterize a particular axial motor syndrome.
- However, patients **rarely present** in this way to a physician in clinical practice.
- Particularly **in the early stages of a disease**, patients might display just one (or at best only a few) abnormal signs of gait, balance or posture.
- Importantly, these individual signs are never pathognomonic for any specific disorder but rather come with an associated differential diagnosis.

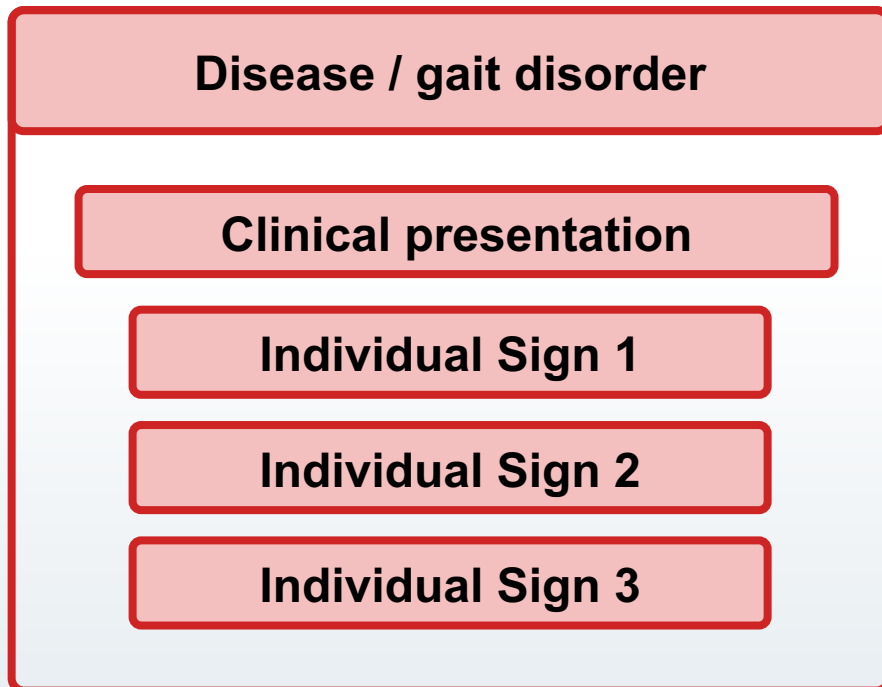

Sitting	
Leaning sideways	<ul style="list-style-type: none"> • Vertebral column deformities • Pisa syndrome: either drug-induced (for example, dopamine receptor antagonists) or associated with neurodegeneration (AD, PD, atypical parkinsonism) • Pusher syndrome (unilateral thalamic stroke), trunk dystonias (including idiopathic Pisa syndrome)
Drifting backwards	<ul style="list-style-type: none"> • PD, atypical parkinsonism (PSP) • Higher-level gait disorders • Trunk dystonia (opisthotonus), often drug-induced (dopamine receptor antagonists)
Forwards dropping of the head (disproportionate antecollis)	<ul style="list-style-type: none"> • MSA, ALS, myasthenia gravis, polymyositis, focal posterior cervical myositis • Drug-induced (dopamine receptor antagonists, amantadine)

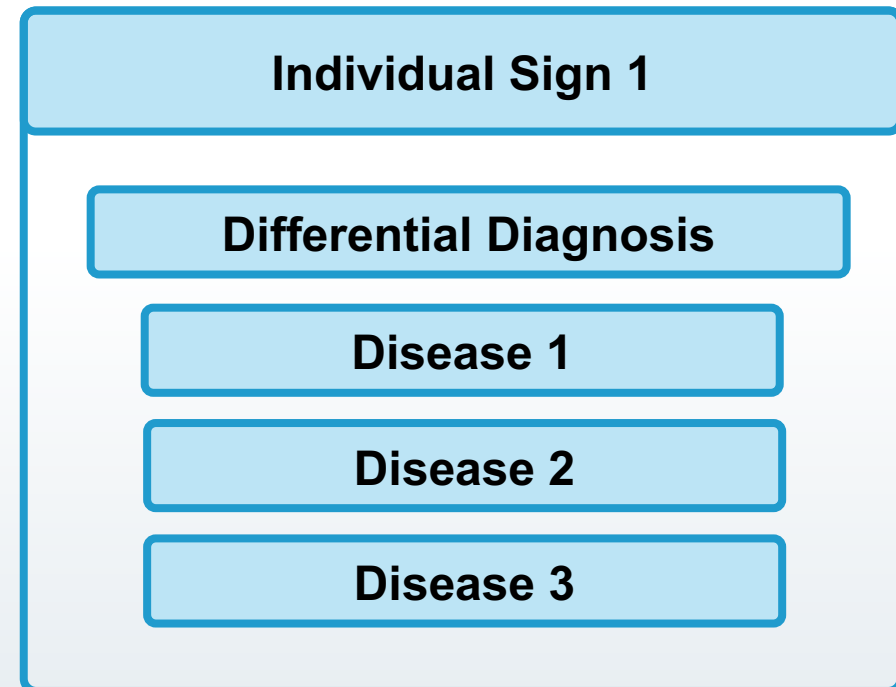
Abnormalities	Suggestions for the differential diagnosis*
Gait initiation, maintenance and termination	
Difficulty starting	PD, atypical parkinsonism: primary progressive freezing of gait; other causes of 'lower-body' parkinsonism (for example, normal-pressure hydrocephalus, vascular parkinsonism)
Sudden episodes of inability to step, particularly when turning or passing through doorways (freezing of gait)	PD, atypical parkinsonism: primary progressive freezing of gait; other causes of 'lower-body' parkinsonism (for example, normal-pressure hydrocephalus, vascular parkinsonism)
Inability to stop (festination)	PD, atypical parkinsonism: other causes of 'lower-body' parkinsonism (for example, normal-pressure hydrocephalus, vascular parkinsonism)
Stance width	
Narrowed base of support	PD, spastic paraparesis (for example, hereditary spastic paraplegia)
Widened base of support	<ul style="list-style-type: none"> • Nonspecific • Atypical parkinsonism, cerebellar ataxia, sensory ataxia, vestibular ataxia, higher-level gait disorders • Extreme in some functional gait disorders
Scissoring of the legs	Spastic paraparesis (for example, juvenile cerebral palsy), dystonia, higher-level gait disorders, Huntington disease (due to chorea), compensation for freezing of gait (for example, in PD), functional gait disorders
Unable to walk in a straight line, sideways deviation (veering) of gait	Unilateral vestibular ataxia, unilateral cerebellar ataxia (consistently veering in a direction ipsilateral to the lesion), functional gait disorders (often veering from side to side)
Step length, height and cadence	
Reduced step height	PD, parkinsonism: foot drop (due to neuropathy of common fibular nerve or sciatic nerve, L5 radiculopathy, Charcot-Marie-Tooth disease, muscular dystrophy, stroke or multiple sclerosis causing distal weakness)
Small steps	<ul style="list-style-type: none"> • Sensitive but nonspecific • Caused by pain (for example, orthopaedic disorders) • Caused by underlying pathology: common in PD, atypical parkinsonism, normal-pressure hydrocephalus, severe sensory impairment of the legs • Compensation for perceived instability
Irregular step size (cadence)	Cerebellar ataxia, vestibular ataxia, higher-level gait disorders, chorea, essential tremor
Reduced stance phase on the affected side (limping)	Pain (antalgic gait) resulting from trauma or arthritis, functional gait disorders
Arm swing	
Unilaterally reduced	Hemiparesis, dystonia, PD, orthopaedic or rheumatological disorders affecting the elbow or shoulder joint unilaterally
Bilaterally reduced	PD, parkinsonism, dystonia, orthopaedic or rheumatological disorders affecting the elbow or shoulder joint unilaterally
Excessive	Chorea, levodopa-induced dyskinesias, normal-pressure hydrocephalus (as compensation for poor body propulsion), hypotonia, functional gait disorders
Tremor appearing in hand during walking	PD, parkinsonism
Posturing with the arm	PD, dystonia, secondary to shoulder and/or neck injury, alien limb phenomenon, functional gait disorders
Movement fluidity	
Dropped foot, lifting the leg higher than normal (steppage gait)	Neuropathy of common fibular nerve or sciatic nerve, L5 radiculopathy, Charcot-Marie-Tooth disease, muscular dystrophy or myopathy, stroke or multiple sclerosis causing distal weakness, foot dystonia causing a functional lengthening of the leg
Knees giving way (buckling of the knees)	Functional gait disorders, quadriceps weakness (for example, limb-girdle myopathy, IBM), cataplexy, negative myoclonus, dystonia
Locking of the knees	Cerebellar ataxia, severe arthrosis or arthritis of the knees, compensation for quadriceps weakness (for example, limb-girdle myopathy, IBM), compensation for severe sensory impairments of the legs, increased external knee extension moment because of pes equinus (due to upper motor neuron syndrome)
Pelvis drop at side of the swing leg, resulting in alternating lateral trunk movements (waddling gait, bilateral Trendelenburg gait)	Bilateral proximal muscle weakness in the leg and hip girdle: common in muscular dystrophy (for example, LGMD, FSHD, Duchenne muscular dystrophy) and metabolic myopathy (for example, thyroid myopathy); bilateral L5 radiculopathy resulting in weakness of gluteus medius, secondary to joint instability (as in Ehlers-Danlos syndromes)
Stiff gait	Many disorders, including myotonia, dystonia, stiff man (or stiff leg) syndrome
Bizarre gait pattern	Chorea (including levodopa-induced dyskinesias), dystonia, higher-level gait disorders, functional gait disorders

Movement fluidity (cont.)	
Twisting of the foot (varus deviation of the hindfoot)	Fixed or dynamic varus due to muscular imbalance around the ankle and tarsal joints (for example, due to upper motor neuron syndrome), young-onset PD (exercise-induced dystonia), cerebrovascular (or other) basal ganglia lesion resulting in dystonia, corticobasal degeneration resulting in dystonia, primary dystonia, functional gait disorders
Gait speed	
Slow	<ul style="list-style-type: none"> • Nonspecific • Perceived imbalance, PD, higher-level gait disorders, functional gait disorders, pain caused by orthopaedic disorders, advanced stages of PSP
Fast, safe	Vestibular syndromes, orthostatic tremor
Fast, unsafe	AD, frontal disinhibition, early stages of PSP

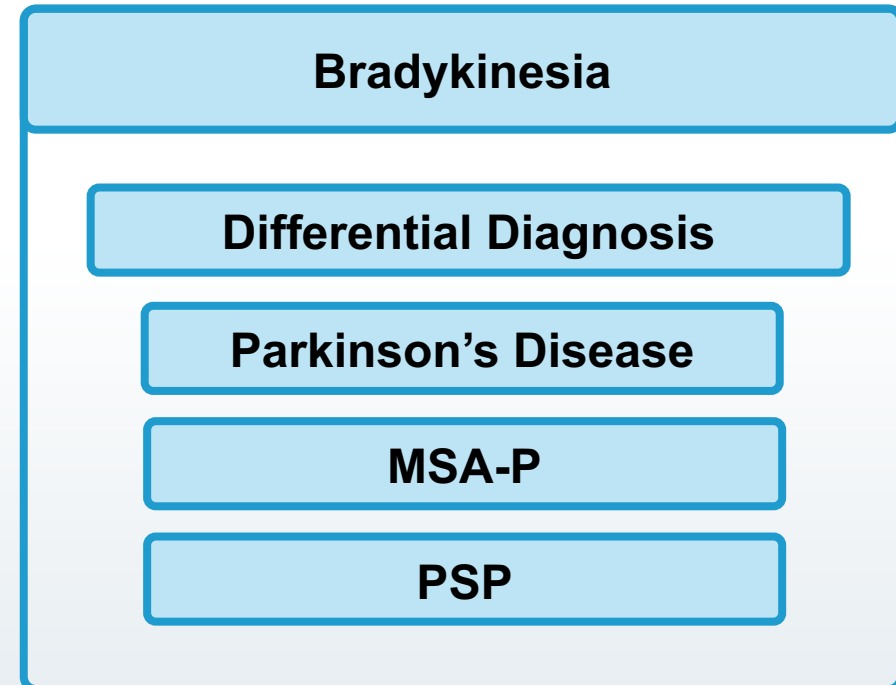

We recommend using a continuous walking protocol and to collect no fewer than **30 steps**.

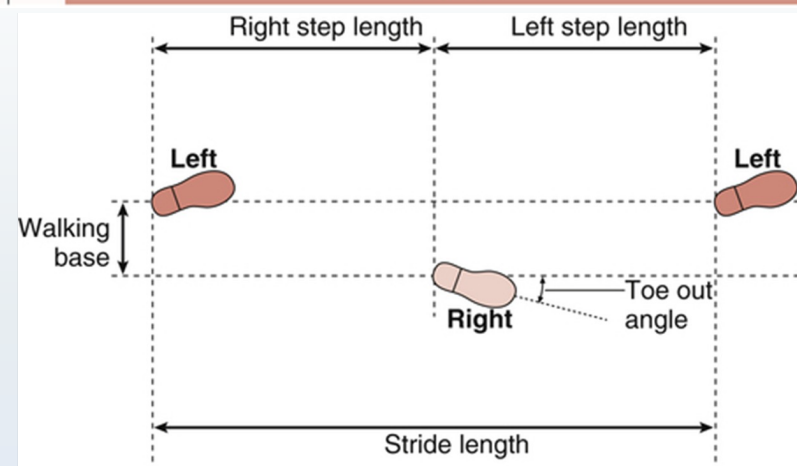
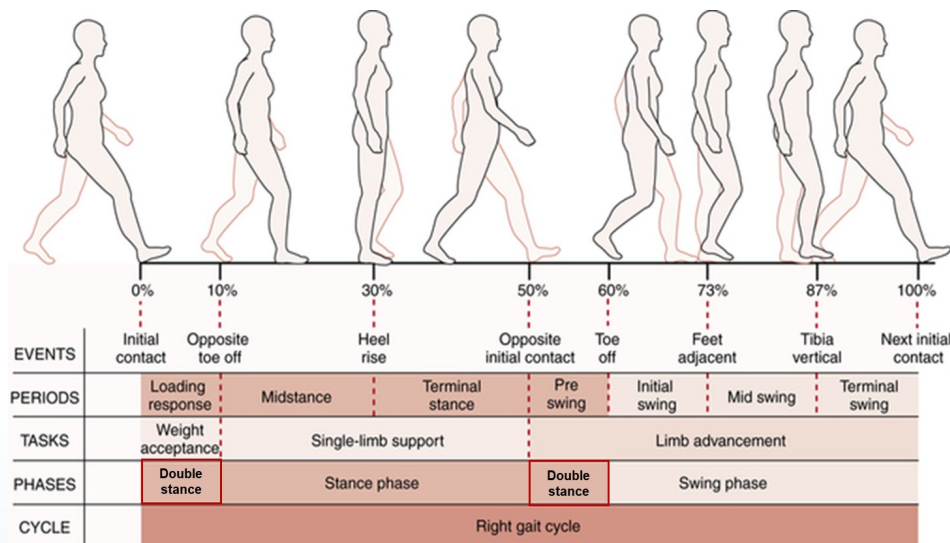







- **Causes: orthopedic diseases**







- Causes: pelvic girdle, proximal muscle weakness, myopathy

Summary

- **Phenomenology of gait disorders**
 - Causes of gait disorders include neurological, orthopedic, and psychiatric conditions (+medical conditions).
 - Multifactorial etiology becomes more common with advancing age.
- **Clinical application of instrumental gait analysis**
 - Spatiotemporal gait parameters are often overlapped among different gait disorders and various within one disease.
 - Instrumental gait analysis require further validation for differential diagnosis of gait disorders.
 - Still, it has possible roles for mild gait impairments, follow-up, or measuring treatment response
- **Detailed history taking, neurological examination, and both classic and sign-based approaches are mandatory to diagnose patients with gait disorders.**
 - especially in patients with complex gait features.
