4. IMPO FINANCIAL CONTRACTS

The amendment is to add \$80,000 to the current contract and extend the time to 12/31/27. The next contract is for Tamm Capital. The firm is utilized to review Bills and engage the State House as needed for the 2026 Legislative session. The cost is \$60,00 (100% locally funded) with an end date of 12/31/26. Next was the discussion for time extension only for Zastro, LLC, Red Envelope Consulting, and CSW for one year, which will be 12/31/26. There was one other time extension for Holliday Collaborative Agency for two years, with an end date of 12/31/27.
