Supporting Survivors of Abuse in Later Life

A Survivor-Centered Approach

Misuse of power is often at the root of abuse in later life. Perpetrators often use tactics of emotional, physical, sexual, spiritual, and economic abuse to gain power over the victim. As a result, many victims lose their sense of personal power — loss of options, the ability to make decisions, or to be confident in oneself.



Consequently, professionals, regardless of their discipline, should be cognizant not to unintentionally replicate the dynamic of power and control. A survivor-centered approach restores control to the survivor by believing them, validating their experiences, prioritizing what's most important to them, and supporting their decisions. This approach is principled on the belief that the older victim is the expert on what can and should be done to advance their safety, justice, and healing.

Strategies for Working with Abuse in Later Life Survivors

Practice survivor-defined

advocacy: Older adults deserve to regain and maintain control over their lives.

- Believe what the older adults tell you and validate their experience without judgment.
- Ask what their concerns and priorities are; some survivors may wish to address their housing, health, mental health, or other concerns that take precedence over their abuse. Focusing solely on the victimization and abuse may not address the older survivor's priorities holistically.
- Recognize that older survivors are resilient and often engage in strategies to keep themselves safe. Build on the strategies older survivors are already using.

- Provide time and space to review their options and help them make informed decisions.
- Support their decisions, remembering they are the expert on their lives.
- Many older survivors want to maintain a relationship with their abuser. The abuser may be an intimate partner, adult child, other family member, or a caregiver. The survivor may want help ending the abuse while still finding a way to have a connection with the abuser.

Reject "one size fits all" approaches: The population of older adults is growing in diversity; culture affects how people perceive elder abuse as well as help-seeking and healing.

 Account for culture, background and identity when considering how to support an abuse in later life survivor. For example, older African Americans who have lived through decades of disparate racial treatment in the criminal justice system may prefer options to safety and justice that don't involve law enforcement. - Explore cultural avenues of support and safety for older adults, such as family networks, culturally-specific organizations, and ways to increase social and community connections.
- Welcome discussions of a survivor's faith; many older adults are faith-affiliated and their faith can be an important factor in their decision-making and safety planning. - For older LGBTQ+ adults who have experienced harassment, stigma, and discrimination, providing affirming outreach and services is particularly important, such as normalizing



using pronouns, avoiding assumptions about gender, and asking about gender identity and sexual orientation. For more information about providing support to older LGBTQ+ survivors, please consult SAGE Advocacy & Services for LGBTQ+ Elders: <u>www.sageusa.org</u>.

 Commit to providing meaningful language access, including translation of materials into languages other than English. Create or obtain a list of certified/qualified interpreters (foreign language and American Sign Language) to contact in advance of meeting with a survivor whose primary language is not English. Never ask family members to interpret. Plan for Accessibility: Some older survivors have vision, hearing, or mobility challenges and may need help addressing medical or disability issues as they evaluate their options.

- When there are concerns about an older adult's cognitive capacity, a survivor-centered approach includes working with health care providers to assess the individual's situation. In some cases, what appears to be limited or diminished cognitive capacity can be a temporary condition that is the result of trauma, inappropriate medications, infection, or lack of sleep, food, or fluids.
- For older survivors with cognitive limitations such as dementia, developmental disabilities, or a traumatic brain injury, it can be difficult or impossible to determine what they want to do and to followthrough with their plans. Learn more about dementia and mild cognitive impairment.
- Be aware of the physical needs of older survivors. Ensure they have access to their medication and food and are able to rest when needed. Ask if they need glasses to see printed materials or if they need material printed in larger font. Ask if they need

to meet in a quiet space to hear and to have a conversation.

Use age-relevant safety planning strategies: Tailor safety planning to

account for an older adult's experience:

- Ensure safety plans consider the survivor's physical health and mobility.
- When developing safety plans for leaving an abusive situation, consider that the survivor may need to pack prescriptions, medical or assistive devices like glasses, hearing aids or canes, as well as important documents For more information, please see NCALL's resource: "<u>Checklist: If</u> <u>You Need to Leave.</u>"
- Consider the caregiving context when safety planning. Some older survivors require care from their abuser; others are providing care for their abuser.
- Focus on harm reduction and decreasing isolation with victims who want to maintain contact with their abuser.
- Older immigrants may fear

Be aware of and avoid ageist assumptions: Many older adults have full capacity and are actively engaged in their communities.

- Don't assume all older adults are frail, mentally incompetent, and/or asexual. Approach older survivors with the same respect, sensitivity, and open-mindedness afforded to all survivors.
- Believe older survivors. Too often older adults are not believed when they report abuse because of ageist assumptions about dementia.
- Identify and build upon older survivors' strengths and skills.



Respect survivor confidentiality and privacy:

Confidentiality is closely tied to survivor safety and helps the older survivor build trust in service providers.

- Generational and cultural beliefs may underscore an older adult's need for privacy and confidentiality when accessing services to address abuse in later life.
- Confidentiality is often statutorily required. These legal requirements include federal and state laws mandating advocates to have a fully informed, signed, and timelimited release of information before any discussion may occur regarding the survivor's situation.

Know your state's mandatory reporting law for elder abuse:

Mandatory reporting requirements vary by state.

- Most states have mandatory reporting laws for elder abuse. Reports are commonly made to adult protective services or law enforcement.
- Engage your organization's attorney to review your state's reporting laws; determine whether you are a mandatory reporter; and understand what information you are required to report.

- If you are a mandatory reporter, let the survivor know this before they make any disclosures so they can make an informed decision about the information they choose to share.
- Have a safety planning process in place for victims who need support if a mandatory report of abuse, neglect, or exploitation has been made to law enforcement or adult protective services.

Provide outreach to older

adults: Raise the visibility of services so older adults know they are welcome.

- Develop outreach materials that depict older adults from a variety of backgrounds and populations. - Use large, readable fonts for print materials and web pages.
 When possible, maximize the contrast of web pages, including graphics, fonts, and backgrounds. For more

- Be intentional about language used to describe abuse; some older adults will not identify with the words "abused" or "victim;" in these cases, describing behavior can be more effective.
- Consider the need for transportation assistance for an older adult to access services.

Work collaboratively: Working together as a community improves outcomes for older survivors.

- Take time to learn about the range of services and supports available to abuse in later life survivors.
- With the older survivors' permission, refer to appropriate agencies for support and assistance.
- Uplift the work of communitybased and culturally-specific organizations by learning about their services, making referrals where appropriate, and exploring partnership opportunities.
- Consult with professionals in a variety of fields on complicated cases to expand available options and ensure that survivors don't fall through the cracks.
 - Only share information with other professionals with the a signed, written, informed,

and reasonably time-limited release from the older individual.
