Student Tool 20: Police Report

Police Report

On February 28, 2013, at 0827 hours, I received a radio call to respond to 4532 Weber Road for a report of a burglary just discovered.

Upon arrival, I made contact with the victim, identified as Nicole Theisman. Theisman stated she is a school administrator for Bayless School District located at 4532 Weber Road. Theisman stated she arrived at her office at approximately 0820 hours on the respond date. Theisman stated she noticed the front door to the building was slightly propped open by a cloth material. Theisman stated she entered the school office via the front door and noticed a window to be in the open position. Theisman stated she then exited the building and contacted this police department for assistance.

Theisman stated she left the school office at approximately 1830 hours on February 27, 2013. Theisman stated she was the last person to leave the building. Theisman stated she secured the front door upon leaving the building. Theisman stated she is unsure if the window was secured, but she knows it was in the closed position. Theisman stated she is the only person with a key to the office.

It should be noted the school office is located in an alleyway. The front door to the office is on the west side of the building. There are three large windows immediately parallel to the front door on the left side.

I observed a white cloth, which appeared to be coated in a red substance, propping the front door to the office ajar. Upon entering the front door, there is a foyer which leads into a office area. The window closest to the front door in the office area was in the open position, The other two windows were in the closed position and secured with a lock. I observed a shoe imprint on the ground in front of the opened window, which has been identified as a possible point of entry. Theisman stated the shoe print did not come from her and she did not notice it when she left the office on February 27, 2013.

Theisman stated the only thing she observed missing was a laptop computer which was located on a desk in the office area. The laptop computer is described as follows:

- Toshiba Laptop Computer
- Black in color
- Model #ST3NX1
- Serial #23857493-35
- Approximate Value of \$1000.00

Theisman stated the rest of the building appeared undisturbed.



Theisman further stated at approximately 1730 hours on February 27, 2013, she observed three males walking down the alleyway in front of the school office. Theismas stated she had never seen the subjects before and did not think there was any reason for them to be there. Theisman described Subject 1 as follows:

- White male
- Fair skin
- Blonde hair
- Slim build
- Between 5'10" and 6:3"
- Wearing dark colored "hoodie" with the hood over his head

Theisman described Subject 2 as follows:

- White male
- Dark complexion
- Dark hair
- Slim build
- Between 5'10" and 6'3"
- Wearing dark colored "hoodie" with the hood over his head

Theisman stated she was unable to recall any description of subject 3.

St. Louis County I.D. Detectives responded to the scene in order to conduct their investigation.

Teletype #34 was entered listing the Toshiba laptop as stolen.

All further investigation to be conducted by Detectives of this Departments Burglary Unit.
