## **Media Literacy: Create and Analyze Production Techniques**

**Expert:** Members of the Gateway Media Literacy Partnership

**Targeted Grade Levels:** This program can be targeted to any grade level between 5 and 12.

**Availability:** Program requests must be made at least two weeks prior to your desired date. When enrolling, let us know at least three possible dates and times you'd like to schedule your interaction.

### **Program Description:**

Gateway Media Literacy Partners, in conjunction with Educate.Today, is sharing their expertise for this program. They believe media literacy is a democracy skill, is a survival skill, a nexus for change, vital to developing critical thinking, is a pathway to better economic decisions and that media literacy empowers citizens to make intelligent and healthy choices throughout their lifetime. This program will start your students on their way to developing the skills necessary to interpret content and understand the implications of the 24/7 barrage of media messages.

By analyzing and understanding the production techniques of media messages, students will be able to deconstruct the messages and understand the persuasive techniques are being used to drive audience wants, needs and values.

The program's conversation will be guided entirely by the topics you wish the presenter to address and the questions your students want answered. For example, if your students are elementary or middle school students who send topics and questions focusing on general media literacy exploration then that will be the direction of your interaction; if your students are high school students wanting to focus on more specific aspects of deconstructing media messages, then that will be the direction of your interaction. Your topic preferences and advance questions are due to us no less than three days prior to your scheduled interaction.

### **Program Objectives:**

Students will:

1. recognize that media messages shape our culture and society
2. recognize that media makers have own experiences, beliefs, values, and motivations
3. evaluate media messages to recognize bias, spin, misinformation, and mistruths
4. discuss the concepts of privacy, security, and safe and responsible use of social media

### **Program Format:**

**Introduction:** Begin with a short bio of the presenter and an overview of the session.

**Heart of the Program:** Presenter will review clips of movies and videos and guide the students in deconstructing the message. Advertisements will be reviewed to build skills in analyzing the persuasive techniques are being used to drive audience wants, needs and values.

**Conclusion:** A quick wrap up, reemphasizing important points.

### **How To Connect for the Program:**

**To Enroll:** Enrollment can occur in any of the following ways:

We will respond to either method of enrollment to finalize a scheduled date for your interaction, make sure you have all program preparatory materials, and handle technical details for your method of connection including test calls.

**Cost and Payment:** \$110—Payment may be made via credit card or school district purchase order. Payment must be received prior to the scheduled program date.

**Cancellation Policy:** Once a date and time has been scheduled for your interaction, you can cancel or reschedule without penalty within 24 hours. After 24 hours and up to 7 days before your scheduled program, we’ll refund 50% of your original fee. Within 7 days of the scheduled date, we do not offer a refund. Should an uncontrollable emergency occur (i.e.: snow day, etc.), we will work with you to reschedule the program for a new date and time but should that prove impossible, we will refund 50% of your original fee. Should our program expert or other circumstance force a cancellation on our end from your original date, we will work with you to reschedule the program for a new date and time that works for you, or we will refund your purchase in full.

### **Pre-Program Activity Suggestions:**

**1. Compare the Versions**—Have students compare a written story to its film version. This could be a story they have previously read or a new one. Have them focus on the visual imagery, sights, sounds, sound effects, and mood established in the film version as compared to the ideas they had while reading the story. How do the choices of the filmmaker in these areas influence their perception/enjoyment/attitude toward the story?

**2. Deconstruct an Advertisement**—Have student view one or more television advertisements and attempt to determine its target audience and the persuasive techniques being used on that audience.

**Note:** Numbers 1 and 2 above are voluntary and designed to get student thinking in ways that will be the focus of their interaction during the point to point program. Students could split into groups to complete the activities or could choose to do them as an extra credit assignment in preparation for the program. Participation in these activities should help them develop advance questions for pre-program activity #3 below.

**3. Send Us Your Advance Questions for Your Interaction:** Work with students in advance of their interaction to determine up to the ten (10) most important questions you’d like to ask the experts during your program. Send these questions to us by completing the Decoding Images Point to Point Worksheet document sent to you with preparatory materials for this program and also available on our Educate.Today website. E-mail it to us at [info@educate.today](mailto:info@educate.today) no less than three days prior to your scheduled interaction. Additional spontaneous questions will be encouraged

during the program, but these questions will be used to organize the conversation.

**4. Share Their Own Work**—If students have examples of their own work they would like reviewed during their point to point interaction, please send them to us at [info@educate.today](mailto:info@educate.today) no less than three days prior to your scheduled interaction.

### **Post-Program Activity Suggestions:**

**1. Share Insights with Each Other**—After the session, have your students discuss what they learned in the program sharing their insights with each other.

**2. Send a Thank You or Insight**—Have students write a letter or make a video for the presenter detailing insights the student gained from session, an appreciation for their participation, and/or another focus area of their choice. **3. Submit a Video or Essay for Possible Publication on Educate.Today**—As part of our mission, Educate.Today is dedicated to publishing student work for other students to learn from. ### **Vocabulary Related to the Program:**

**Access:** The ability of media consumers to produce their own texts and to have those texts acknowledged by the agenda setting media. Also, the ability of media consumers to respond to the dominant media.

**Agenda-setting:** The ability of the media to tell people what and whom to talk and think about. Also refers to those media that have more credibility than their competition.

**Audience:** The group of consumers for whom the media text was constructed as well as anyone else who is exposed to the text.

**Branding:** The process by which a commodity in the marketplace is known primarily for the image it projects rather than any actual quality.

**Censorship:** The practice of suppressing a text or part of a text that is considered objectionable according to certain standards.

**Construct or Construction:** The process by which a media text is shaped and given meaning through a process that is subject to a variety of decisions and is designed to keep the audience interested in the text.

**Consumers:** The audience for whom a commercial media text is constructed and who responds to the text with commercial activity.

**Critical:** A reflective position on the meaning, biases or value messages of a text.

**Critical Viewing:** The ability to use critical thinking skills to view, question, analyze and understand issues presented overtly and covertly in movies, videos, television and other visual media.

**Deconstruction:** The process by which the audience identifies the elements that make up the construction of meaning within a text.

**Demographics:** Measurable characteristics of media consumers such as age, gender, race, education and income level.

**Marketing:** The way in which a product or media text is sold to a target audience.

**Mass Media:** Mass media refers to those media that are designed to be consumed by large audiences through the agencies of technology.

**Media Education:** Traditionally, it's the process by which one learns the technical production skills associated with creating media texts. More recently, it has also included the intellectual processes of critical consumption or deconstruction of texts.

**Media Literacy:** The process of understanding and using the mass media in an assertive and non-passive way. This includes an informed and critical understanding of the nature of the media, the techniques used by them and the impact of these techniques.

**Media:** The plural form of medium; the term has come to mean all the industrial forms of mass communication combined.

**Narrative:** How the plot or story is told. In a media text, narrative is the coherent sequencing of events across time and space.

**Production:** The industrial process of creating media texts as well as the people who are engaged in this process.

**Production Values:** Describes the quality of a media production proportional to the money and technology expended on the text.

**Propaganda:** Any media text whose primary purpose is to openly persuade an audience of the validity of a particular point of view.

**Stereotypes:** A form of media representation by which instantly recognized characteristics are used to label members of social or cultural groups. While often negative, stereotypes can contain an element of truth and are used by the media to establish an instant rapport with the audience.

**Text:** The individual results of media production: a movie, a TV episode, a book, an issue of a magazine or newspaper, an advertisement, an album, etc.

**Transparency:** The quality of a media text by which it appears to be natural rather than constructed.

**Word-of-mouth:** Informal way in which media products become known by audiences.
