- Crime Scene: The Ultimate Guide to Forensic Science, 2003 by Richard Platt (Author). An introduction to the high-tech world of forensic science shows how the latest methods of scientific detection are used to uncover the truth about a crime scene.
- CSI Expert!: Forensic Science for Kids, 2008 by Karen Schulz (Author). Includes more than 25 in-depth activities on fingerprinting, evidence collection, bloodstain identification, forensic careers, ballistics, and much more.

Lemony Snicket-like humor and decoding puzzles through research and handy gizmos, lots of fun.
