Review Your Options

The benefit choices you make during Annual Enrollment will take effect January 1, 2026. If you're a new hire, you'll have 31 days from your hire date to make your elections.

After you enroll, you can only make changes during the year if you have a qualifying life event—such as getting married or divorced, welcoming a new addition to your family, or enrolling in or losing your other group coverage—and report it within 31 days to the Rockwell Alight Service Center (RASC). Otherwise, you have to wait until the next Annual Enrollment period.

ARE YOU A STUDENT ASSOCIATE?

You're eligible only for medical coverage and the Retirement Savings Plan—401(k). You must enroll in medical coverage within 31 days of your start date.

If you're a benefits-eligible full-time employee scheduled to work at least 20 hours per week. If you're a student employee working full time, you're eligible for medical coverage and the Retirement Savings Plan only.

Your Spouse/Domestic Partner

Including registered same-sex/opposite-sex domestic partner with their name, birthday, and Social Security number for proof of dependent eligibility.

Your Child(ren)

Up to age 26 (or older if permanently disabled), with their names, birthdays, and Social Security numbers for proof of dependent eligibility.

COVERING A SPOUSE/ DOMESTIC PARTNER?

If your spouse/domestic partner is eligible for subsidized medical coverage under another employer, your contributions will increase by \$780 if you earn less than \$50,000 annually and by \$1,800 if you earn more than \$50,000 annually.

You'll also pay tax on the coverage's value (imputed income) for your spouse/domestic partner or their child if they don't qualify as dependents for federal income tax. This adjustment doesn't apply if your partner is a retiree, self-employed, or a Rockwell employee.

Every year, we take a close look at our benefits and consider what changes are necessary. We want to provide you with comprehensive, inclusive coverage—both at work and home. Our benefits prioritize your health and well-being so you're better equipped to take on anything life throws at you.

New Prescription Drug Vendor

Rockwell is preparing to transition from CVS Caremark to Optum Rx for prescription coverage. This change is expected to be smooth, with minimal disruption for you and your family. If you're enrolled in UnitedHealthcare, you'll receive one ID card for both medical and prescription coverage. If you're enrolled in Centivo, you'll receive a separate ID card from Optum Rx in addition to your medical ID card.

New Life Insurance Changes

If you're currently enrolled or plan to enroll in Spouse Life, Child Life, and/or AD&D Insurance, you'll need to confirm which dependents should be covered. This update helps ensure that only eligible dependents are enrolled. Be prepared to provide their information during enrollment.

Increase in Medical Contributions

In line with our commitment to keeping expenses as affordable as possible for you and your family, Rockwell Automation continues to pay the majority of your premium costs. However, due to the continual rise of health care costs, you'll notice an increase in your medical plan contributions. This increase is still below the national average.

Increase to Spousal Surcharge

To help manage rising health care costs in a fair and balanced way, the spousal surcharge will be adjusted for 2026. If you earn less than \$50,000 annually, the surcharge will be \$65 per month, and if you earn more than \$50,000 annually, the surcharge will be \$150 per month. This change reflects the shared responsibility of managing health care expenses and aligns with industry practices across the country.

Health Clinic Enhancements

Rockwell is making enhancements to onsite health clinic services. This includes expanding behavioral health support through the Milwaukee office, offering a flat structure for onsite services, and improving medication access with a curated prescription list. You can expect targeted communications at your location—ensuring the right resources are available where they're needed most.

401(k) Plan Updates

Starting in 2026, we'll be making changes to the Rockwell Retirement Savings Plan (the "401(k)" Plan) as we implement two key provisions of the SECURE 2.0 Act related to catch-up contributions for those aged 50+. These provisions are designed to align with new federal guidelines and enhanced savings opportunities for eligible employees. Fidelity will communicate with you directly if you're impacted by the changes. No action is required at this time.

COVERING YOUR SPOUSE?

If you're covering a spouse/domestic partner, you must also actively confirm if they don't have subsidized medical coverage available through their employer, otherwise you'll default to paying more per year (\$780 each year if your annual salary is less than \$50,000 or \$1,800 if at least \$50,000).

You can enroll in the **Broad Access HSA** or the **Broad Access** medical plans through UnitedHealthcare (UHC). If you live in Eastern Wisconsin, you have a third medical plan option to choose from—the **High-Performance** medical plan through Centivo.

FIVE WAYS TO SAVE ON PRESCRIPTION DRUGS

Prescription drug coverage automatically comes with your medical plan. So, let's make sure you get the most for your money.



Go Generic (When Possible)

Talk to your doctor about your options.

- Generics are drugs that have the same active ingredients and meet the same safety standards as brand-name drugs but without the brand name and expensive price tag.
- Formulary brands are brand-name drugs included on your medical plan's formulary at a discounted rate. The formulary is a list of specific prescription drugs (and costs) covered by your medical plan.
- Nonformulary brands are brand-name drugs not included on your medical plan's formulary.
 This means you'll pay the most out of pocket for these medications.



Use a Network Pharmacy

Drug prices at in-network pharmacies are less expensive than out-of-network pharmacies. You save money because you pay a percentage of the lower in-network cost. So stay in network and receive a better price. You can find in-network pharmacies at optumrx.com.



Try a 90-Day Supply for Maintenance Drugs

Maintenance drugs are drugs you take on an ongoing basis to treat chronic conditions, such as high cholesterol or high blood pressure.

For new maintenance drugs, you'll be allowed two 30-day supplies from any network retail pharmacy before you're asked to receive any additional fills in a 90-day supply from Optum Rx Home Delivery Pharmacy's Mail Service Member Select Program. You'll receive a letter describing the program in the mail prior to the start of your new benefits. You can opt out of the program at any time after January 1, 2026, by calling the Optum Rx Customer Care Center at **1.800.356.3477**.



Use Tax-Free Dollars

If you've signed up for a Health Savings Account (HSA) or a Flexible Spending Account (FSA), you can use that money to pay for your prescription drugs. And remember, it's tax-free and already in your budget, which makes good money sense. If you don't contribute to an HSA or FSA, you may have other options—like discount cards—to help you save money. Ask your pharmacist for details.



Pay \$0 for Certain Specialty Medications

If you're enrolled in the Broad Access or High-Performance medical plans and take specialty prescription drugs, you'll be automatically enrolled in the Optum Rx Variable Copay Card Program to get your covered specialty medications at a discounted rate. If you're eligible, Optum Rx will call you directly. For questions, call Optum Rx Specialty Pharmacy at **1.855.427.4682.**

HEALTH SUPPORT

Your medical plans include programs and services to help you and your family live a healthier life.

Health Support Programs—For All Medical Plans

If you're enrolled in **any of the medical plans**, take advantage of these resources that help you find quality care and save money.

2nd.MD Medical Experts

Get the right diagnosis and treatment—and avoid unnecessary costs—with the help of 2nd.MD Medical Experts. At no cost to you, you can:

- Work with top specialists to review your medical case and offer recommendations for diagnosis or treatment.
- Ask your medical questions and get expert answers.
- Get the right care for a wide range of medical conditions including cancer, heart disease, digestive issues, mental health, and more.

Infertility Services

Whether you're thinking about starting a family or need extra support, you receive a medical lifetime maximum of \$25,000 and a prescription drug lifetime maximum of \$10,000 for an infertility diagnosis and fertility care due to medical necessity. Examples include in vitro fertilization (IVF) to treat infertility and fertility preservation after a cancer diagnosis.

Fertility, Perimenopause, and Menopause Support

You and your adult dependents enrolled in a Rockwell medical plan have access to Mayen. In addition to virtual care for pregnancy, postpartum, and returning to work after parental leave, you have access to unlimited education and coaching from a network of reproductive and family health experts, such as OB-GYNs, doulas, reproductive endocrinologists, fertility educators, adoption/surrogacy coaches, nutritionists, mental health coaches, and career coaches. Maven also provides personalized support for perimenopause, menopause, and post menopause, including managing symptoms and support in finding the right treatments. Plus, you'll be connected to a dedicated Care Advocate who can provide 24/7 support, learning resources, and access to community forums to engage with others on the same journey.

Autism Spectrum Disorder Support

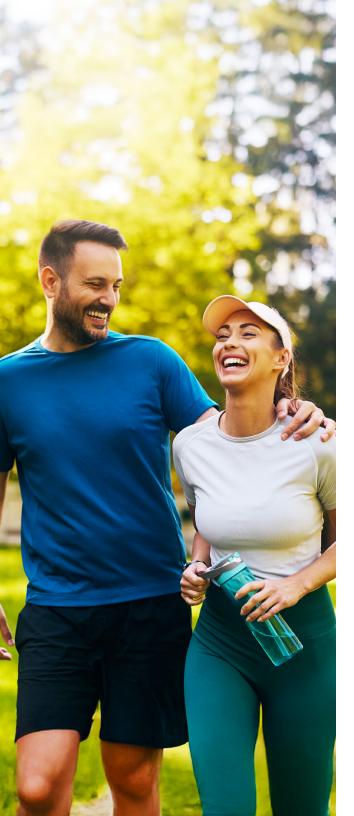
If you or someone in your family has been diagnosed with autism spectrum disorder, you have coverage for intensive behavioral health services, such as applied behavior analysis (ABA), which is designed to reinforce adaptive behaviors, reduce maladaptive behaviors, and improve ageappropriate skills.

HOW THE PLAN WORKS

The Rockwell Automation Retirement Savings Plan—the 401(k) plan—is an easy, tax-friendly way to help you save for your retirement. Your contributions and Rockwell's contributions to your Retirement Savings Account work together to help you achieve your goals. You contribute a portion of your paycheck into your account and Rockwell enhances your savings by making additional contributions. The 401(k) plan is administered by Fidelity.



Here's How the Retirement Savings Plan Works

Meet Mateo. He's a 43-year-old full-time employee at Rockwell Automation with a hire date of October 26, 2020. He wants to save and invest a piece of his paycheck before taxes are taken out. He knows that Rockwell matches \$0.50 for every \$1.00 he contributes up to 7%—and he doesn't want to leave money on the table—so he contributes 7% of his eligible pay. Also, Mateo's age plus service make him eligible to receive a 4% non-elective contribution (NEC).

Mateo contributes 7% of his pay into the 401(k) plan.

You can contribute up to 50% of your pay on a pre-tax, Roth, or after-tax basis. If you're age 50 or older, you're also eligible to make catch-up contributions. You're immediately 100% vested in your own contributions to the plan. See page 28 for annual limitations on contributions.

Company Matching Contribution

Rockwell Automation matches \$0.50 for every \$1.00 on the first 7% of pay you contribute each pay period on a pre-tax, Roth, or after-tax basis. Catch-up contributions aren't eligible for company match. Contribute at least 7% to take full advantage of the company match. If you're contributing less than 7% you may be missing out on free money.

Rockwell's Annual NEC Contribution

Once a year, Rockwell Automation automatically contributes 3%-7% of your eligible pay, called a non-elective contribution (NEC). When we say "pay" for NEC, we mean your actual calendar-year. This includes your regular salary, overtime, shift differentials, bonuses, commissions, and sales incentives. To receive this NEC, you must be employed on the last business day of the calendar year.

WHAT HAPPENS IF YOU DON'T ENROLL?

Automatic Enrollment: If you don't make any elections, you'll automatically be enrolled at a 3% pre-tax contribution rate after 30 days of employment. If you don't want to participate in the plan, consider opting out of automatic contributions and change your contribution rate to 0% by the date noted on the notification letter. Keep in mind that contributions made to the Retirement Savings Plan can't be refunded to you.

Automatic Increase: Each January, your contribution rate will automatically increase by 1% until you reach 7% unless you opt out of this feature.

Automatic Spillover: If you reach the IRC pre-tax and Roth 401(k) contribution limit before the end of the year, your contributions will automatically "spill over" or switch to regular after-tax contributions at the same rate you elected for pre-tax and/or Roth 401(k) contributions.

Default Investment Election: Your own contributions and any Company contributions will be invested in a default target fund based on your birth date and target retirement date.

INVESTMENT MANAGEMENT

Investing is how you help your savings grow. Within the Rockwell Automation Retirement Savings plan, you have the flexibility to select from investment options that range from conservative to moderately aggressive. A BrokerageLink option is also available. Depending on how involved you want to be, you can create your own investment strategy or let the professionals handle it for you.

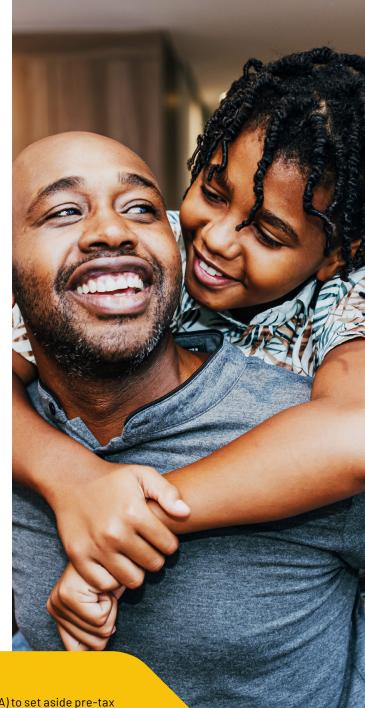

Paid Vacation

The number of paid vacation days you have depends on how long you've worked for Rockwell (prior service with a Rockwell Automation affiliate or service with Rockwell Automation in another country may count). You must be scheduled to work at least 20 hours per week to be eligible for vacation or holiday pay, and your vacation and holidays are prorated.

Caregiver Leave

You can take up to two weeks paid caregiver leave when you care for eligible family members, such as your spouse, child, or parents. If you give birth to or adopt a child, you can use caregiver leave for additional bonding time after your parental leave is exhausted.

You're eligible for caregiver leave if you've worked at Rockwell Automation for 12 months, you're scheduled to work 20 or more hours per week, and you have Federal Family and Medical Leave (FMLA) available to use. The care you provide must be for an eligible family member—not for yourself.
